Kultaranta Talks

President of the Republic Sauli Niinistö hosted a debate on foreign and security policy at Kultaranta on 16–17 June 2013. The Kultaranta Talks featured a wide-ranging discussion on the current and future state of Finland's foreign and security policy.

President Niinistö opened the event on the evening of Sunday, 16 June. The opening debate of the second day focused on the big picture of foreign and security policy and Finland's place on the world stage.

Before noon, the participants were divided into small working groups that spent the morning discussing the state of Finnish foreign policy from various perspectives, including values and interests, resources, and the future of the EU. In the afternoon, the working groups focused on the options of Finland's security policy: NATO, the EU and Nordic cooperation. The leaders of the working groups summarised the discussions during the closing debate.

The participants invited to the event included around one hundred foreign and security policy experts from various areas of society, including politics, research, administration, business, NGOs and the media. The **opening** and **closing sessions** of the event can be watched in YLE Areena.

The event was organised by the Office of the President of the Republic in cooperation with FIIA.

FIIA to take part in SuomiAreena

FIIA will organise panel discussions at SuomiAreena in Pori in July. The first panel discussion will focus on current issues in Finnish foreign policy on 17 July. The panel consists of representatives from five political parties. On 18 July, the second panel consisting of researchers will discuss Nordic cooperation and NATO as options in Finnish security policy.

Programme Directors appointed

Mika Aaltola, Juha Jokela and Arkady Moshes will continue in their current positions in the next three-year period from 1 January 2014 to 31 December 2016.

Dr **Mika Aaltola** leads the Global Security Research Programme, which focuses on global trajectories of security that have significance for the European and Finnish security environments. In his research, Dr

Aaltola has focused for instance on US domestic and foreign policy as well as great power relations.

Dr **Juha Jokela** leads the European Union Research Programme, which focuses on the EU's external relations, institutional development and economy. Dr Jokela's research focuses on the EU's foreign policy. Recently, he has published on EU's role in the G20.

Dr **Arkady Moshes** leads the EU's Eastern Neighbourhood and Russia Research Programme which focuses especially on Russian domestic and foreign policy. Dr Moshes has published extensively on issues such as Russia-EU relations and Ukrainian and Belarusian domestic and foreign policy.

While also having their own research agendas, the principal responsibility of the Programme Directors is to lead their research

In addition, the issue shed light on the **new geopolitics in Asia** and found out why many of China's neighbors are keeping an eye on Chinese policies with growing suspicion.
