

## TURKEY AND THE EU'S SECURITY IN TIMES OF TROUBLE: WHAT IS THE NATURE OF THE RELATIONSHIP IN TERMS OF SECURITY COOPERATION?

A year has passed since the approval of a new Constitution that will turn Turkey's regime into an executive presidency. Simultaneously, Turkey's relations with the Western institutions, both the EU and NATO, have become increasingly strained. This seminar will ask what is the current nature of the Turkey-EU relationship. How does Turkey's increasingly problematic relationship with NATO affect EU-Turkey cooperation? What is Turkey's current and future place in the EU's security architecture? Considering its highly authoritarian domestic system and aggressive foreign policy in the Middle East in particular, is it still possible to regard Turkey as an important security-provider to the Western world?

FIIA organises this seminar as a member of the Europe-wide VIADUCT network, which aims to enhance the visibility of academic research on EU-Turkey relations.

**Paul T. Levin** is the founding Director of the Stockholm University Institute for Turkish Studies (SUITS). The author of *Turkey and the European Union: Christian and Secular Images of Islam*, and co-editor of *Migration from Turkey to Sweden: Integration, Belonging and Transnational Community*, Dr. Levin is a frequent commentator on Turkish affairs in Swedish and international media. He is a founding member of the Consortium for European Symposia of Turkish Studies, Associate Researcher at the Swedish Institute for International Affairs, Research Fellow at the Swedish Research Institute in Istanbul, and member of the German Marshall Fund's Trilateral Strategy Group. He received his PhD from the School of International Relations at the University of Southern California.



**Hanna Ojanen** is adjunct professor (docent) of international relations at the University of Helsinki. She holds a doctorate from the European University Institute (Florence). Her previous positions include Jean Monnet Professor at the University of Tampere (Faculty of Management), Director of the Research Programme on the European Union, Finnish Institute of International Affairs, and Head of Research, Swedish Institute of International Affairs. Her research focuses mainly on European foreign, security and defence policy and on inter-organisational relations (particularly EU-NATO-UN). Her most recent book is *The EU's Power in Inter-Organisational Relations* (Palgrave Macmillan 2018).



**Toni Alaranta** is a Senior Research Fellow at the Finnish Institute of International Affairs. He is a doctor of social sciences, University of Helsinki, 2012. His main research interests include Turkish politics and history and Turkey-Europe relations. Mr. Alaranta is the author of two recent books on Turkey, *National and State Identity in Turkey: The Transformation of the Republic's Status in the International System* (Rowman & Littlefield, 2015), and *Contemporary Kemalism: From Universal Secular-Humanism to extreme Turkish Nationalism* (Routledge, 2014).



**Teija Tiilikainen** is the Director of the Finnish Institute of International Affairs (FIIA). Previously, Dr. Tiilikainen was the Director of the Network of European Studies at the University of Helsinki (2003-2009). She has also served as Secretary of State at the Ministry for Foreign Affairs of Finland from 2007 to 2008. Dr. Tiilikainen was the Special Representative of the Prime Minister of Finland in the Convention on the Future of Europe in 2002-2003. Currently, she is also Editor-in-Chief of *Ulkopolitiikka* – the Finnish Journal of Foreign Affairs.
