# Terms and Conditions of the Get your Deel payments at Utoppia Program

# Effective as of May, 2025

#### I. DEFINITIONS

- a. "App" is the application called "Utoppia" for the provision of financial services (hereinafter, "Utoppia").
- b. "Program" consists of two promotions: i. Cashback for Opening New Accounts: Users who open a new account at Utoppia after May 26th and fund it with USD 250 or more from Deel within the first 30 days of opening will receive a cashback of USD 20. # Effective as of June 16, 2025

# I. DEFINITIONS

- a. "App" is the application called "Utoppia" for the provision of financial services (hereinafter, "Utoppia").
- b. "Program" is a Utoppia campaign designed to incentivize existing and new users to activate their accounts through funding for the first time their utoppia account (FTA) from the following platforms: Wise, Payoneer, OnTop, or Airbnb. Users who have never made an FTA in Utoppia, and fund their account with USD250 or more between June 16 and July 15, 2025, from any of these platforms will be eligible for the benefits. Once the first FTA is completed with USD250 or more, that platform will be defined as the only valid one for accessing the monthly benefit.
- c. "Utopian/s" are App users with active products purchased through the App.d. "Payment Platforms" are designated as payment platforms to all the senders who are identified with the following names in the Utoppian balance: Wise, Payoneer, OnTop, or Airbnb. Funds that are not identified in the client's account balance with those names will not be considered "Payment Platforms," regardless of who the sender was.

#### II. BENEFITS

# Terms and Conditions of the Utoppia Referral Program "Member Get Member"

Effective as of August 8, 2025

Utoppia, Inc. and our affiliates or subsidiaries (collectively "Utoppia," "we," "us," or "our") operate a platform that provides our customers (individually or collectively, "you" or "Utoppians") with a mobile phone application (the "Platform App"), called "Utoppia", which allows Utoppians access to Utoppia's services. These "Member Get Member" Terms and Conditions of the Utoppia Referral Program (these "Referral Terms and Conditions"), govern the Referral Program (defined herein) campaign offered by Utoppia to Utoppians with an Account (defined herein). We may update these Referral Terms and Conditions from time to time, at our discretion, and you agree that it is your responsibility to check for any updates. We will provide updates as required by law. Defined terms used herein but not otherwise defined shall have the meanings ascribed to them in those certain General Terms of Service of Utoppia (the "Terms of Service").

### I. "MEMBER GET MEMBER" REFERRAL PROGRAM.

- i. **Referral Program.** The Referral Program, also known as "*Member Get Member*" allows Utoppians (in good standing and having no debts owed to Utoppia) to invite individuals, using their Invitation Code, to download and use Utoppia's Platform App. Upon the completion of a Successful Referral, Referring Utoppians and/or Referred Utoppians shall be entitled to receive a Benefit from Utoppia.
- ii. Successful Referral Requirements. In order for a referral to be deemed a "Successful Referral", the individual referred must (the following being the "Criteria"): (1) be a human person, of legal age, residing in one of the countries where Utoppia accepts clients; (2) download the Platform App and enter the Invitation Code delivered by the Referring Utoppian; (3) successfully perform the identification process, which includes the onboarding, user registration, and Account opening by Utoppia of the Referred Utoppian through the Platform App; (4) initiate and complete, within 30 calendar days from the moment the Account is opened, money- in transactions (Domestic ACH, Domestic and International Wire) for the total amount of USD 250 (Two hundred and fifty US Dollars) (the "Transactions") or more; or make a single prepaid card purchase of USD 100 (One hundred US Dollars) or more (non-cumulative) within 30 days of account opening. There are no restrictions on the type of purchase; provided, however, that the prepaid card expense cannot be a canceled purchase and (5) for the USD250 total amount, eligible transactions include only Domestic ACH transfers, Domestic Wires, and International Wires. Any funds transferred via non-eligible means will not count toward the required amount. There will not be counted the amount received from another Uutoppia account (whether via pier to pier or other transfer not), card withdrawals or interest payments from the investment account. Full compliance with what is detailed above will be called the "Process".
- iii. By participating in the Referral Program, you, the Referring Utoppian, and the individuals you refer, the Referred Utoppians, accept these Referral Terms and Conditions and any Modifications (defined herein) or suspension of these Referral Terms and Conditions that are established by Utoppia in its sole discretion.
- iv. <u>Referred Utoppians Participation in Referral Program.</u> At the time of Account opening, Utoppia will provide the Referred Utoppian with their own Invitation Code, which such Referred

Utoppian may also share with their own individual contacts to also become a Referring Utoppian and receive the Benefit in that capacity, as well, in accordance with these Referral Terms and Conditions.

# II. REFERRAL PROGRAM BENEFITS.

- i. **Benefit Defined.** The "**Benefit**" is the prize that Utoppia will deliver to the Referring Utoppians and Referred Utoppians for Successful Referrals (hereinafter jointly and/or individually called "**Recipient(s)**") who are deemed to be in full compliance with these Referral Terms and Conditions.
- ii. <u>Award of Benefit.</u> Referring Utoppians will be rewarded with a one-time Benefit sum of 10 USD (Ten US Dollars) for each Successful Referral that complies with the Criteria by registering with such Referring Utoppians Invitation Code, which will be credited to the Referring Utoppian's Account when eligible as set forth in these Referral Terms and Conditions.
- iii. Each Referred Utoppian, from each Successful Referral will be awarded with a one-time Benefit sum of 10 USD (Ten US Dollars) for the specific Successful Referral which will be credited to the Referring Utoppian's Account when eligible as set forth in these Referral Terms and Conditions.
- iv. Condition to Eligibility for the Receipt of Referral Program Benefit. It will be an exclusive condition to receive the Benefit that each Referring Utoppian and/or Referred Utoppian (that a Successful Referral) owns an active Account with Utoppia, opened through the Platform App, when the referral by the Referring Utoppian is made and when they are eligible to receive the Benefit. The Benefit will be credited to the Account within 30 calendar days of the Referred Utoppian's successful completion of the Criteria. If for any reason the Referring Utoppian's and/or the Referred Utoppian's Account is no longer open when the Benefit is to be credited, neither Referring Utoppian nor the Referred Utoppian (whichever is applicable) shall be entitled to receive the Benefit and hereby waives any claim to its payment of the Benefit. In each case, the user who receives a Benefit, whether Referring Utoppian or the Referred Utoppian, will be solely responsible for the payment of any and all taxes and other costs levied and/or related to receiving the Benefit.

#### III. EXCLUSIONS AND RESTRICTIONS.

- i. Limited to First-time Users Only. The Referral Program applies exclusively to registrations of first-time users of the Platform App. The Referral Program specifically excludes as referrals all those who, on the start date of the Referral Program, are or have previously been users of the Platform App or clients of Utoppia. This exclusion also includes those who, at any time, have completed the Criteria, regardless if an Invitation Code was utilized by such person. In such cases, any and all users who meet the above scenarios shall not be considered Successful Referrals, and consequently no Benefit will be granted to them or their respective Referring Utoppians.
- ii. Benefit Specific to Invitation Code Holder. The Benefit will be granted solely and exclusively to the holder of the Invitation Code that the Successful Referral registered at the time of registration. No person shall be entitled to receive a Benefit or compensation of any kind if their designated Invitation Code was not registered by the referred individual. This exclusion includes any omissions or errors conducted during the referred individuals Criteria and/or in the event the individual was a Successful Referral who registered the Invitation Code of another Referring Utoppian, or if the Invitation Code was entered with a typing error by the individual referred.
- iii. **No Entitlement to Records.** Utoppia shall not be required to reveal information about any referrals conducted, regardless of whether such referrals under the Referral Program have been successful

- or not, nor any information regarding the Invitation Codes provided by the Referring Utoppians used by such referred individuals for their registration, nor any other type of information retained by Utoppia for this Referral Program. Any determination regarding the successfulness of a referral and/or calculation of Benefits by Utoppia will be final.
- iv. Utoppians may provide their Invitation Code and refer as many contacts as they wish. Notwithstanding the foregoing, Utoppia shall only grant the Benefit for up to a maximum of 20 (twenty) Successful Referrals ("Maximum Referrals") for each Referring Utoppian, subject to the availability limit set forth in Section IV(i) of these Referral Terms and Conditions. Nevertheless, Utoppia may, at its own discretion, modify the maximum number of Successful Referrals eligible for the Benefit under these Referral Terms and Conditions.

  - i. <u>Term.</u> The Referral Program shall remain in effect from August 8, 2025, and will last for a 365 calendar days since August 8,2025 (the "Term"), or until the 10,000 (ten thousand) Benefits granted are exhausted (the "Referral Benefit Cap Limit"), whichever occurs first. The Term and quantity will be automatically renewed for an additional 60 calendar days term until Utoppia, at its own discretion, elects not to renew and informs you of its decision not to renew.
- ii. <u>Utoppia's Right to Extend Term or Referral Benefit Cap Limit.</u> Utoppia reserves the right to extend the Term of this Referral Program and/or the Referral Benefit Cap Limit, for all or some of its Referral Program participants, at any time and without prior notice. By participating in this Referral Program, you agree and acknowledge your unrestricted and unappealable acceptance of these Referral Terms and Conditions.
- iii. Modifications by Utoppia. Utoppia may, in its sole discretion, modify, update, suspend, extend, and/or revoke these Referral Terms and Conditions and the Referral Program ("Modifications"). - ii. <u>Governing Law</u>. These Referral Terms and Conditions shall be governed by the laws of the State of California.
- iii. <u>Security Measures.</u> Utoppia, in its discretion, may introduce any and all the security measures it deems appropriate for this Referral Program and Utoppia reserves the right to suspend the Referral Program at any time. In the event any fraud or any other irregularity is detected, Utoppia shall be exonerated from any type of responsibility and such Indemnification Obligations shall be enforced.
- iv. Right to Revoke or Suspend Invitation Code Access. Utoppia reserves the right to revoke,

- suspend, or cancel the Invitation Code of any Referring Utoppian at its sole discretion.
