Council discussion included: confirmation of the history of \$1 per year lease agreements for non-profits; granting the \$1 per year lease could aid in the Gary Center's future success and was pivotal in VCC's decision to approve the merger; verified staff confirmed that the Gary Center merging with VCC will increase reimbursements for services as a Federally Qualified Healthcare Center (FQHC) which could improve their financial condition; facility improvements completed by the Gary Center; verification the City of La Habra has enough demand for services to support a second FQHC facility; and expression of support of the lease agreement.

Councilmember Beamish expressed opposition to Resolution No. 3 regarding Transient and Occupancy Tax. He stated there are other means to collect fees from Air Bed and Breakfast (Air B & B's) establishments, such as zoning codes.

City Attorney Jones clarified that this legislation would include Air B & B establishments.

City Manager Sadro stated that this legislation would give the City addition tools to collect from Air B & B (residential rental of rooms) services. He confirmed that staff is generally supportive of more local control and that the City does not currently have a transient and occupancy tax. He confirmed that if this legislation passed that it would not create a tax for the City. He clarified that if voters approved a transient and occupancy tax in the future, the City would have more tools to collect from Air B & B establishments.
