

# GUIDELINES FOR THE **PARSHURAM KUND FESTIVAL-2023** FACILITATION CENTRES

## **SERVICES/FACILITIES TO BE PROVIDED TO PILGRIMS/VISITORS/TOURISTS AT PARSHURAM KUND FESTIVAL-2023 FACILITATION CENTRES**

The Pilgrims/Visitors/Tourists visiting to Parshuram Kund during **PARSHURAM KUND FESTIVAL-2023** period i.e., **12<sup>th</sup> January to 16<sup>th</sup> January 2023** shall be facilitated as per the following guidelines at the following **Facilitation Centres** set up at the following Check Gates by the respective District Administration in collaboration with the District Administration, Lohit:

1. **DIRAK CHECK GATE MAHADEVPUR, NAMSAI DISTRICT**
2. **SHANTIPUR, PARBUK, LOWER DIBANG VALLEY DISTRICT**
3. **SUNPURA CHECK GATE, SUNPURA, LOHIT**
4. **DIGARU CHECK GATE, TEZU, LOHIT**
5. **MEDO CHECK GATE, WAKRO, LOHIT**

### **Please Note:**

1. The designated Nodal Officers shall take efforts to go through this guideline carefully and thoroughly.
2. All Nodal Officers shall take efforts to coordinate pro-actively with the concerned Nodal Officers of the respective District of Assam/Arunachal Pradesh.
3. It shall be the duty of the Nodal Officers to ensure that the coordination is being done before and during the Festival Period on daily basis for effective public/pilgrims' facilitation.
4. Urgent issues must be escalated timely to appropriate Nodal Officer of Lohit district or higher authorities.
5. In case of any clarification regarding these guidelines, office of the Deputy Commissioner, Lohit shall be the final authority.

**2. SUNPURA CHECK GATE, SUNPURA, LOHIT**

- a. Sunpura-Alubari-Chowkham Tinali-Medo-Wakro-Parshuram Kund

**3. SHANTIPUR CHECK GATE, PARBUK, LOWER DIBANG VALLEY DISTRICT**

- a. Shantipur-Parbuk-Bolung-Koronu-Alubari-Chowkham Tinali-Medo-Wakro-Parshuram Kund

**ONE-WAY / ONLY EXIT ROUTE**

**1. DIGARU CHECK GATE, TEZU, LOHIT**

- a. Parshuram Kund-Tohangam-Demwe-Tezu-Digar

**Explanatory Note:**

- a. Digar-Tezu-Demwe-Tohangam-Parshuram Kund Route (Hilly Terrain Route) shall be closed for all types of traffic from outside **going towards Parshuram Kund via Tezu.**
- b. However, the above route shall be available for limited traffic (**excluding HMV**) exiting from Parshuram Kund going towards Tezu. (Parshuram Kund-Tohangam-Demwe-Tezu-Digar)

**PUBLIC HEALTH ADVISORY**

**As per guidelines of the State Health Task Force, Arunachal Pradesh the following public health measures shall be applicable to control and combat any possible surge in COVID-19 cases in the State with immediate effect:**

- c. Covid vaccination sessions to continue to be operational in all health facilities.
