# **Reference to VeraSol**

VeraSol is a registered service mark of CLASP. When describing the VeraSol program, capitalize the letters "v" and "s" in VeraSol. Variants without correct capitalization (e.g. Verasol, verasol) are not permitted.

When describing VeraSol in publications and communications materials such as media releases, please use the following approved language:

#### **VeraSol-Certified Products**

These Communications and Branding Guidelines are applicable to solar energy systems up to 350 Wp that have been issued a valid Lighting Global verification letter or VeraSol certificate.

You may use one or more of the following statements to describe a VeraSol-certified product in advertising, marketing, and sales materials. Other statements may also be permitted on a case-by-case basis. Please contact <u>info@verasol.org</u> for permission prior to using any other statement about testing or certification not listed below.

# i. For products certified to the Lighting Global Quality Standards

- a. This is a VeraSol-certified product.
- b. This product has been tested and certified to the Lighting Global Quality Standards.
- c. This VeraSol-certified product has been tested to IEC TS 62257-9-5 and certified to the Lighting Global Quality Standards.

#### ii. For products certified to the quality standards in IEC TS 62257-9-8

- a. This is a VeraSol-certified product.
- *b.* This product has been tested and certified to the quality standards in IEC TS 62257-9-8.
- c. This VeraSol-certified product has been tested to IEC TS 62257-9-5 and certified to the quality standards in IEC TS 62257-9-8.

# VeraSol-Tested Solar Appliances and Equipment

These Communications and Branding Guidelines are applicable to solar appliances and equipment tested independent from a solar energy system. VeraSol tests all solar appliances and equipment to the Global LEAP Awards Test Methods for fans, televisions, refrigerators, or solar water pumps. VeraSol-tested solar appliances and equipment receive a detailed test report and a product performance benchmarking summary that highlights key results.
