**RESOLUTION OF THE BOARD OF DIRECTORS

Approving the policy on the execution of contracts/transactions in 2022 with the below threshold between Vinhomes and related parties in accordance with the Charter, the Law on Enterprises, and the Law on Securities:

4	<i>Contracts/transactions for daily, regular business activities of Vinhomes</i>	<i>Less than VND 2,000 billion.</i>

Article 2. Implementation

Authorizing the Chairperson of the Board of Directors, based on actual needs and business activities of the Company, to (i) approve each transaction in detail, and/or (ii) assign the

Chief Executive Officer to approve, decide, amend, add terms and conditions; and sign contracts/transactions with Vinhomes's subsidiaries and other related parties (including cancellation, termination, liquidation, etc.) and execute such contracts/transactions in accordance with the thresholds approved by the Board of Directors and the laws.
