SINCE VINSON HALL OPENED ITS DOORS IN 1969 AS A RETIREMENT HOME FOR THE WIDOWS OF MILITARY OFFICERS, IT HAS GROWN INTO A VIBRANT SENIOR LIVING COMMUNITY, HOME TO NEARLY 400 INDIVIDUALS. THROUGH THE YEARS, VHRC HAS EXPANDED BUT MAINTAINED ITS MILITARY CONNECTION. THOSE WHO LIVE IN VHRC'S INDEPENDENT LIVING COMMUNITY ARE RETIRED MILITARY OFFICERS OR CAREER GOVERNMENT OFFICIALS AND THEIR FAMILIES.
