There should be no contact, conversations, bumps, posing for pictures, signing autographs, etc. with any freshman, sophomore, or junior.		

Protect yourself using the tips below*:

٠

- Educate the high school coaching staff and PSAs on NCAA rules prior to visiting the high school campus
 - Example to coach: "As a reminder, I can only have contact with seniors during a contact period."
 - Example to underaged PSA: "Hey John, I'll be at your school tomorrow. I won't be able to talk to you because of NCAA rules, but I wanted you to know I was stopping by."
- If HS coach tries to arrange face to face meeting with an underaged PSA, you need to put in writing you cannot meet him (e.g., "Since John is a junior, I won't be able to speak with him, as I can only meet with seniors.")
- If you have face-to-face contact with a PSA, your greeting should include NCAA rules to protect yourself:
 - \circ $\;$ Example: "Hey John, NCAA rules don't allow me to speak with you, but it was great seeing you.
 - \circ $\;$ Never ask a question so you do not start a conversation triggering an impermissible contact.

Keep messages for documentation purposes
