Ensuring compliance with the Innovaccer Health Cloud

Overview Payers need to comply with the CMS Interoperability and Patient Access final rule. According to the rule—which CMS hopes will create industry-wide, barrier-free data exchange—payers must give patients easier access to their healthcare data as well as implement provider directory APIs (HL7 FHIR Release 4.0.1) that can be used by third-party programmers to create applications for members. In addition to helping organizations achieve true data transparency, the rule will help payers leverage data to identify gaps in care, execute timely interventions, and get new insights for population health management.

However, most payers are concerned about integrating data sources. They need to collate all member data dating back to January 1, 2016, ensuring its quality and streamlining it for CMS compliance.

Challenges

The new CMS regulations are designed to ensure higher qualities of care and member satisfaction. However, disparate, complex systems make compliance challenging because payers need to:

Collate member data dating back to January 1, 2016

Aggregate data at the member level and update members within one business day of processing or receipt

Ensure that the required data is high-quality

Access provider and pharmacy directory data and ensure that updates are available within 30 days

Map data across various sources and formats to FHIR profiles and resources

Certify third-party applications based on specific criteria

Authenticate members, manage consent, and educate members on data security and privacy risks

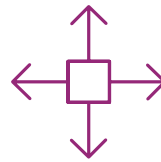

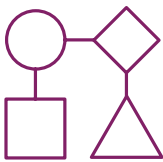

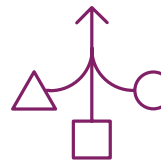
Payer data connectivity The solution integrates source systems and data warehouses containing required data and maps required data elements to FHIR-based schematics for continuous data feeds to servers.



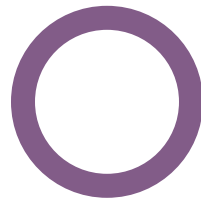
FHIR server and API gateway The solution launches a payer admin portal to manage FHIR APIs and third-party applications.

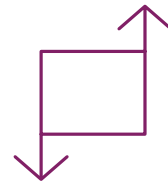
