Purpose and legal basis of data processing
In connection with the operation, maintenance and the provision of the Website as an information society service, we process your personal data for the following purposes: <ul style="list-style-type: none">• Online content provision: as a part of operating the Website, in order to provide you with our content and services, we place cookies on your device used for browsing as per our Cookie Notice. In the case of functional cookies, data processing is based on our legitimate interest.• Analytics: we keep and evaluate the information about your last visits on our Website and how you navigate between different parts of it for analytic purposes in order to understand how people use our Website so that we could make it even more intuitive; for this purpose, we rely on your consent.• Targeted advertisements: we use the information based on the articles you read to show you advertisements that you may find interesting; in this context, we rely on your consent for this purpose.• Conducting prize games: when conducting prize games on the Facebook page of our Website according to our Rules on Prize Games, the processing of your data about your participation, selecting the winner, communication with the winner and the delivery of the prize is based on your consent. In connection with the prize games, we are obliged by the law to keep hold of Value Added Tax and accounting invoices that may contain your personal data.• Use of the function 'Recommend a place!': when receiving and processing your recommendation given via the Webpage's 'Recommend a place!' function, we process your email address and the content of your recommendation based on our legitimate interest.• Responding to inquiries: processing your personal data is necessary to manage your questions and complaints in your inquiry, which processing is based on our legitimate interest.
Recipients of data transfer
We may share your personal data with our service providers and cooperating partners helping us in our activity operating inside and outside the territory of the European Union. Appropriate guarantees have been inducted and we maintain the security of your data.
Your rights
You have the right to freely withdraw your consent at any time without restriction in case of processing data based on consent. Withdrawal of consent shall not affect the lawfulness of processing data based on consent prior to withdrawal. You have right to request information from us about your personal data processed, you have the right to rectification, the right to object and the right to erasure personal data with certain limits, the right to request a copy of the data, to exercise your right to data portability or to request partly the restriction of processing.
RIGHT TO OBJECT
You are entitled to object against processing your personal data at any time, for reasons related to your special situation; in this case we might no longer process your personal data. Should you have the right to object, and you exercise it, your personal data will no longer be processed for such purposes by us. There is not any cost for exercising this right.

Categories of personal data processed	<p>We process the following personal data for the above-mentioned purposes:</p> <ul style="list-style-type: none">• Contact data: contact details, content of inquiry.• Data necessary for conducting prize games: Facebook username, profile picture, User ID, content of comment.• Data of the winner of the prize game: winner's name, gender, email address, postal address, telephone number, name of the account managing bank and bank account number.• User data: cookie IDs, device data.
Legal basis of processing personal data	<p>We rely on the following legal bases when processing your personal data:</p> <ul style="list-style-type: none">• In case of your consent, we process your personal data based on Article 6(1)(a) of the GDPR.• On the basis of performance of legal obligation based on Article 6(1)(c) of the GDPR.• Our or third party's legitimate interest pursuant to Article 6(1)(f) of the GDPR.

We process your personal data based on the legal bases for the purposes as follows:

When maintaining the Website, it is in our legitimate interest to place certain data on your device used for browsing to ensure the basic operation of the Website. It comes with the necessary and proportionate limitation to your right to data protection as in this case it is preceded by our legitimate interest for the basic operation of our Website. Furthermore, in case you consented, we have the possibility to place certain data in connection with convenience, analytics and marketing purposes on your device.

When you send us a recommendation using the 'Recommend a place!' function of our Website, it is in our legitimate interest and can be reasonably expected to review and process the information in your recommendation and to use it to create content for our Website.

It is also in our legitimate interest to manage and respond to your requests, questions and complaints you send us, and to involve external services, such as a law firm, if necessary. You may reasonably expect us to process your personal data in connection with your inquiry.

Duration of the storage of your personal data

We process your personal data only for the period that is necessary to perform our obligations and services, and to achieve the aim for which we collected the data. If processing your personal data is no longer necessary, we delete your data.

- Data processed on the basis of your consent will be processed until you withdraw your consent.
- Your inquiries will be preserved for one year.
- Data related to conducting prize games and the data of the winner that are necessary to hand over the prize are processed until the winner has received the prize.
- We preserve the data necessary to comply with our obligation of keeping hold of Value-Added-Tax-related invoices for five years.
- We preserve the data necessary to comply with our obligation of keeping hold of accounting-related invoices for eight years.
- We process the data in connection with operating the Website (online content providing, analytics, targeted advertisements) until the end of your session, with a maximum of one year.

Recipients of data transfer

Your personal data may only be accessed on a 'need-to-know basis' by our authorised employees and by our service provider business partners' employees.

We transfer your personal data for the following categories of recipients:

- Data processors:** we may transfer your personal data to certain third parties in order to process the data on our behalf in accordance with instructions and for the purpose of the processing. These processors are contractually obliged to implement appropriate technical and organisational measures to protect the personal data and to process the personal data only in accordance with the instructions.

International data transfers

In connection with the use of the Website, we may transfer your personal data to countries outside the European Economic Area ('EEA'), to the United States of America. If we transfer your personal data outside the EEA, we take appropriate measures to ensure that your personal data is adequately protected, regardless of the country to which the data is transferred, in compliance with our legal

Right to access: You are entitled to receive verification/feedback from us regarding to whether or not your personal data is being processed, and if so, you have the right to access your personal data. 2. Right to rectification: You have the right to rectification of your personal data on request. 3.
