**WESTBOROUGH WATER DISTRICT  
HIGH-EFFICIENCY TOILET (HET) REBATE PROGRAM ELIGIBILITY RULES**

**PROGRAM DESCRIPTION:**

1. Rebate amount of \$50 for each 1.3 gallon (or less) high-efficiency toilet (HET) installed.
2. New construction projects are not eligible as state law requires installation of HET toilets in all new construction.
3. Limit: Three (3) HET rebates per residential account or Ten (10) HET rebates per multi-family or commercial accounts within a five-year period.
4. One application per water utility account number, only.

**REQUIREMENTS:**

1. Must be a customer in the Westborough Water District area.
2. Purchase and **install** an EPA WaterSense labeled HET 1.3 gallon (or less).
3. HETs must be purchased from July 1, 2022 and June 30, 2023, and the rebate application postmarked, within 90 days of the HET purchase date.
4. Submit completed application **along** with original receipt for EPA WaterSense labeled HET 1.3 gallon (or less). If you need the receipt(s) returned, please enclose a self-addressed, stamped envelope with your application.
5. Installation of HET may be subject to inspection.
6. After requirements are met, rebate checks will be issued within six weeks.
