## A. Review/Approve 2018/2019 Capital Improvement Projects.

General Manager Barrow reviewed the list of Capital Improvement Projects recommended for fiscal year 2018/2019 and answered questions from the Board.

#### B. Report on Ground Water on Seville Way by Joubin Pakpour.

Engineer Joubin Pakpour presented report to the Board on the ground water on Seville Way. Mr. Pakpour reported that there were many challenges to capture the water on Seville including testing to see whether or not the water is safe to use. Mr. Pakpour stated that the cost of the infrastructure to capture the water on Seville Way could easily exceed one million dollars while the District would only receive about \$2,870 annually if there were an agencies who wanted to buy the water from the District. Mr. Pakpour stated that there were many other projects the District could consider from the Capital Improvement Project list he was preparing.

Director Bautista request that this item be tabled until the entire Board could be present to discuss whether or not to proceed.

Report on Ground Water on Seville Way was tabled until the next Board meeting in June, no action taken.

# C. Review/Approve Proposals for Electrical Repairs at Skyline Storage Building.

General Manager Barrow reported that the District had received two proposals for electrical repairs at the Skyline Storage Building. Mr. Barrow reported that Muscio Electric submitted a proposal for \$13,255 and Telstar Instruments submitted a proposal for \$11,963.06. Mr. Barrow recommended approval of the low bid from Telstar Instruments.

Director Bautista moved to approve the low bid from Telstar instruments, seconded by Director Medina.
