# Election of the President and Vice-Presidents of the Conference of the Parties

## Report by the Convention Secretariat

### Purpose of the document

The present report provides information to the Conference of the Parties (COP) to the WHO Framework Convention on Tobacco Control on the election process for the President and Vice-Presidents of the COP, according to Rule 21 of the Rules of Procedure of the COP.

### Action by the Conference of the Parties

The COP is invited to note the present report and consider adopting the annexed draft decision to elect the officers who will constitute the Bureau for the following session of the COP.

## **BACKGROUND**

1. The election of officers of the Conference of the Parties (COP) to the WHO Framework Convention on Tobacco Control (WHO FCTC) is governed by Rule 21 of the Rules of Procedure of the COP. Before the end of the Tenth session of the COP (COP10), the COP shall elect a President and five Vice-Presidents, one of whom shall act as Rapporteur, from among the representatives of the Parties present at the session. These officers shall constitute the next Bureau of the COP. Each of the World Health Organization (WHO) regions shall be represented by one member of the Bureau.
2. The term of office of the members of the Bureau shall commence at the closure of COP10 and will continue until the closure of the Eleventh session of the COP and will include any intervening extraordinary session.
3. The functions of the Bureau are set out in Rule 24ter of the Rules of Procedure of the COP.
4. WHO regions were encouraged to nominate their respective candidates to constitute the next Bureau of the COP as early as possible, ideally before the opening of COP10.
