Date and place

COP11 will take place at the International Conference Centre (CICG) in Geneva, Switzerland. The first plenary meeting opens at 10:00 on Monday, 17 November 2025, and the session is expected to close no later than 13:00 on Saturday, 22 November 2025, Central European Time (CET).

Smoking and the use of electronic tobacco or nicotine delivery devices are not permitted in any indoor area, including in all areas allocated for the meetings.

Registration and credentials

Online registration is required for COP11. Delegates who have not yet completed their registration must register via the online registration system at: <https://indico.un.org/event/1016257/>. Credentials must be uploaded in order to complete the registration process.

Badges

Participants will be able to collect their badges before the opening of the session at the Registration Desk located on the ground floor of CICG. The Registration Desk will be open as follows:

Due to space limitations in the main Plenary room, Parties will be allocated a specific number of seats according to their delegation size. Overflow rooms will be available for delegates who are not able to be accommodated in the main Plenary room.

Interpretation and statements

Interpretation will be provided in the six official languages of the United Nations (Arabic, Chinese, English, French, Russian and Spanish).

Delegates are requested to send a copy of their statement to interpret@who.int at least 30 minutes in advance for interpretation and records purposes. This does not prevent delegates from making changes upon delivery, but it will facilitate clarity and accuracy in all languages.

When submitting a statement by email please specify, both in the subject line of the email and at the top of the attached statement, the name of the country/group, the meeting (for example, Plenary, Committee A or Committee B) and the number of the relevant agenda item.

Delegates are requested to deliver statements at a normal speaking pace. Rapid delivery risks impeding clarity and accuracy in interpretation.

Statements provided in advance are treated as confidential and checked against delivery for the purpose of the official record.
