The Animal By-Products (Enforcement) (England) Regulations 2013

Temporary Approval of Incineration Plant

1. In accordance with Regulation 14 of The Animal By-Products (Enforcement) (England) Regulations 2013 and Article 24 of (EC) No. 1069/2009, the Secretary of State approves:

to operate high capacity incinerators: 1) Matthews Environmental Solutions model Surefire SA50-2 serial number C 5598.1 (6 chambered pet carcase cremator rated 110 kg/hr in total) and 2) Matthews Environmental Solution model Surefire SA50-3 serial number C 5598.2 (the equine unit rated 150 kg/hr and one individual chamber rated 50 kg/hr each) on the premises to incinerate equine carcases being Category 2 Animal By-Products and pet animal carcases being Category 1 Animal By-Products.

- 2. The incinerators shall be located at the approved premises in a designated building. (and completely separate from livestock, feed and bedding in the case of on farm incinerators).
- 3. The incinerator must be operated in accordance with the manufacturer's instructions.
- 4. The incinerator must be subject to an annual service by the manufacturer or an independent service engineer who should be able to confirm that the incinerator is still capable of meeting the requirements of Commission Regulation (EU) No. 142/2011.
- 5. Each time the incinerator is used, a record must be made of the date, quantity and description of animal by-products incinerated. The temperature in the secondary chamber must be recorded either automatically or manually every 2 hours for at least 10% of burn cycles.
- 6. Slag and bottom ash from the incinerator must have less than 3% Total Organic Carbon or less than 5% loss on ignition. Either of these tests must be completed annually with compliant outcome.
- 7. This temporary approval will expire 24th November 2023. This approval may be suspended or revoked in the event of non-compliance with the above Regulations.

- 1. All the conditions of The Animal By-Products (Enforcement) (England) Regulations 2013/The Animal By-Products (Enforcement) (Wales) Regulations 2014 and Regulation (EC) No. 1069/2009 and Commission Regulation (EU) No. 142/2011 must be complied with.
- 2. Changes to the ownership, address or operation of an approved animal by-product premises must be notified to APHA at the above address.
- 3. The operator must take all necessary steps to ensure that:
 - animal by-products are handled and stored safely and incinerated without undue delay in such a way that they are reduced to dry ash
 - the dry ash is not removed from the combustion chamber unless combustion is complete
 - intermediate storage and transport of the dry ash takes place in a closed container to prevent dispersal in the environment
 - on farm pig/poultry carcase incinerators the dry ash is disposed of in accordance with the relevant exemption registered with the environmental regulator:
 - o or otherwise the dry ash is disposed of to a landfill with an appropriate environmental permit, or as directed by the environmental regulator
 - o and/or in the case of individual carcase cremations, the ash may be returned to the animal owners.
