to operate 2 High Capacity incinerators, linked to one secondary chamber and particulates reduction equipment [Cremator 3 - pet carcasses; Cremator 4 Cat 1,2 & 3 ABP] on the premises to incinerate Category 1/Category 2/Category 3 animal by-products.

- The incinerators shall be located at the incinerator building, A505 Main Road.
- For at least 10% of burn cycles the temperature reading shall be recorded every 2 hours (minimum) during the burn cycle.
- 4. The incinerator must be operated in accordance with the manufacturer's instructions.
- The incinerator must be subject to an annual service by the manufacturer or an independent service engineer who should be able to confirm that the incinerator is still capable of meeting the requirements of Regulation (EC) No. 142/2011.

This approval is valid from 15/1/2016 and revokes and replaces all previous approvals
