

CO-CREATION: A COLLABORATION METHODOLOGY

Collaboration and co-creation ensure USAID establishes and leverages relationships with key stakeholders as a way to identify areas of shared interest and potential cooperation, avoid duplication of efforts, share knowledge about what works and what needs adjustment, and develop new, innovative ideas to address shared development challenges.



Collaboration

Refers to strategic engagement among a wide range of internal and external stakeholders.



Co-creation

Is a collaborative, time-limited process that focuses on generating a specific, shared outcome.

WHAT IS CO-CREATION?

USAID defines co-creation as a design approach that **brings people together to collectively produce a mutually valued outcome, and uses a participatory process that assumes some degree of shared power and decision-making.**



Through co-creation, USAID brings together organizations and individuals to share and improve upon ideas, generate innovative and sustainable solutions to development challenges, and foster local ownership.



Multi-stakeholder, multi-day facilitated workshops

Co-creation can be a part of, or take place outside of, a procurement process.
