### COUNT 1

The Grand Jurors, aforesaid, in the name and behalf of the citizens of Georgia, charge and accuse **LANDON JEAN PIERRE TERREL** with the offense of **FELONY MURDER, O.C.G.A. 16-5-1(c)**, for that the said accused, in the County of Cobb and State of Georgia, on and about the evening of August 14, 2017 into the morning of August 15, 2017, while in the commission of a felony, Elder Neglect, did cause the death of Adam Neil Bennett, a human being, irrespective of malice, as further described in Count 3, which is incorporated herein by reference, contrary to the laws of this State, the good order, peace and dignity thereof.

### COUNT 2

and the Grand Jurors, aforesaid, in the name and behalf of the citizens of Georgia, further charge and accuse **LANDON JEAN PIERRE TERREL** with the offense of **FELONY MURDER, O.C.G.A. 16-5-1(c)**, for that the said accused, in the County of Cobb and State of Georgia, on and about the evening of August 14, 2017 into the morning of August 15, 2017, while in the commission of a felony, Elder Abuse, did cause the death of Adam Neil Bennett, a human being, irrespective of malice, as further described in Count 4, which is incorporated herein by reference, contrary to the laws of this State, the good order, peace and dignity thereof.

### COUNT 3

and the Grand Jurors, aforesaid, in the name and behalf of the citizens of Georgia, further charge and accuse **LANDON JEAN PIERRE TERREL** with the offense of **ELDER NEGLECT, O.C.G.A. 16-5-101**, for that the said accused, in the County of Cobb and State of Georgia, on and about the evening of August 14, 2017 into the morning of August 15, 2017, did knowingly and willfully deprive Adam Neil Bennett, an elder person, age 65 or older, of health care, contrary to the laws of this State, the good order, peace and dignity thereof.

#### COUNT 4

and the Grand Jurors, aforesaid, in the name and behalf of the citizens of Georgia, further charge and accuse **LANDON JEAN PIERRE TERREL** with the offense of **ELDER ABUSE, O.C.G.A. 16-5-102**, for that the said accused, in the County of Cobb and State of Georgia, on and about the evening of August 14, 2017 into the morning of August 15, 2017, did knowingly and willfully inflict physical injury and physical pain upon Adam Neil Bennett, an elder person, age 65 or older, by striking him, contrary to the laws of this State, the good order, peace and dignity thereof.

#### COUNT 5

and the Grand Jurors, aforesaid, in the name and behalf of the citizens of Georgia, further charge and accuse **LANDON JEAN PIERRE TERREL** with the offense of **ELDER ABUSE, O.C.G.A. 16-5-102**, for that the said accused, in the County of Cobb and State of Georgia, on and about the evening of August 14, 2017 into the morning of August 15, 2017, did knowingly and willfully inflict mental anguish upon Adam Neil Bennett, an elder person, age 65 or older, by striking him and failing to obtain medical treatment, contrary to the laws of this State, the good order, peace and dignity thereof.
