March 2013 incidents

5. While reviewing this material, I have been able to identify the dates of two incidents of violence that took place in March 2013. As I explained in my earlier statements, there were numerous incidents of violence in March 2013 which coincided with Johnny's drug use. I now realize that the incident I had initially described as having taken place on 8 March 2013 took place on 22 March 2013. There was a separate incident on 8 March 2013. The incident I describe involving the painting took place on 22 March 2013, which is apparent from the photographs now at Tab 148(f) (which show Johnny's cocaine in

my kitchen at my house on Orange) and was on one of the days Johnny was due to be filming a documentary with Keith Richards.
