This would preclude the defense from seeking independent testing by their own expert. The Defendant is requesting the following: That the court order the State to not pursue any testing on remaining DNA samples until such time as the defense can obtain half of all samples to allow defense to perform their own DNA testing of all samples. That the court order the State to provide all records, reports, documentation related to the testing that has been performed to date. That the court order the State to allow defendant's DNA expert to go directly to any lab testing such samples to review, copy, photograph, and document any and all processes, tests, procedures and testing procedures that will be performed on the additional samples and have been performed to date. Provide to the defense any and all other evidence related to DNA testing in this case.

That the court order the testing agency performing any test to photograph, record and document any serology, microscopy or other visual test performed or to be performed on any DNA sample related to this case. That the State be ordered to allow Defendant's DNA expert to examine all quantification evidence, extraction evidence used and documented by the State's lab

That the court set an expedited hearing on this matter to avoid the state moving on its intention to consume all DNA evidence prior to defense having the opportunity to even review such evidence.
