ONE COUNT (L. POZO ILLAS)

The Grand Jurors of the County of Jefferson, in the name and by the authority of the Commonwealth of Kentucky, charge:

COUNT ONE

That on or about the 11th day of August, 2019, in Jefferson County, Kentucky, the above named defendant, **LAZARO OSMANY POZO ILLAS**, committed the offense of Murder by intentionally or under circumstances manifesting extreme indifference to human life wantonly caused the death of Christopher Schulz.

COUNT TWO

That on or about the 11th day of August, 2019, in Jefferson County, Kentucky, the above named defendant, **LAZARO OSMANY POZO ILLAS**, committed the offense of Assault in the First Degree when he intentionally caused serious physical injury to Brian Hovekamp, by means of a deadly weapon or a dangerous instrument;

OR

under circumstances manifesting extreme indifference to the value of human life when he wantonly engaged in conduct which created a grave risk of death to another and thereby caused serious physical injury to Brian Hovekamp.

COUNT THREE

That on or about the 11th day of August, 2019, in Jefferson County, Kentucky, the above named defendant, **LAZARO OSMANY POZO ILLAS**, committed the offense of Wanton Endangerment in the First Degree when, under circumstances manifesting extreme indifference to the value of human life, he wantonly engaged in conduct which created a substantial danger of death or serious physical injury to Jonatan Leon Mancilla, when while intoxicated the defendant operated an automobile and caused a collision.

COUNT FOUR

That on or about the 11th day of August, 2019, in Jefferson County, Kentucky, the above named defendant, **LAZARO OSMANY POZO ILLAS**, committed the offense of Wanton Endangerment in the First Degree when, under circumstances manifesting extreme indifference to the value of human life, he wantonly engaged in conduct which created a substantial danger of death or serious physical injury to John Pene Morillo, when while intoxicated the defendant operated an automobile and caused a collision.

COUNT FIVE

That on or about the 11th day of August, 2019, in Jefferson County, Kentucky, the above named defendant, **LAZARO OSMANY POZO ILLAS**, committed the offense of Operating a Motor Vehicle While Under the Influence of Intoxicants First Offense by operating a motor vehicle in the Commonwealth of Kentucky while

(a) the alcohol concentration in his blood or breath is 0.08 or more based on the definition of alcohol concentration in KRS 189A.005;

OR

(b) under the influence of alcohol;

OR

(c) under the influence of any substance or combination of substances which impairs one's driving ability;

OR

(d) the presence of a controlled substance in 189A.010(12) is detected in the blood;

OR

(e) under the combined influence of alcohol and any other substances which impairs one's driving ability;

OR

(f) being under the age of 21 years had an alcohol concentration of .02 or more based on the definition of alcohol concentration in KRS 189A.005;

AND

The defendant operated his motor vehicle that caused a collision resulting in death or serious physical injury as defined in KRS 500.080.

COUNT SIX

That on or about the 11th day of August, 2019, in Jefferson County, Kentucky, the above named defendant, **LAZARO OSMANY POZO ILLAS**, committed the offense of Operating of a Motor Vehicle by a Person Without an Operator's License by operating a motor vehicle upon the highways when he failed to secure a valid operator's license.
