The following Affidavit is submitted to the Court to document the probable cause in support of a request for the issuance of an Arrest Warrant for **Kallungi, Dane Oliver, DOB: 12/23/1982, AGE: 38, SSN:**

This offense is fully documented in Colorado Springs Police Department Report 19-11949 detailing the offense(s) of:

Your Affiant, **Detective Michael Lee, 3820**, a sworn police officer with the City of Colorado Springs currently assigned to the Homicide Unit, herein after referred to as I.

I have personal knowledge of the details concerning this investigation, which are documented in Colorado Springs Police Department report number **19-11949** titled **Murder in the First Degree**. Unless otherwise noted, all addresses listed within this affidavit are located within the City of Colorado Springs, County of El Paso, and State of Colorado.

On April 4, 2019 at 1238 hours, officers with the Colorado Springs Police Department were dispatched to 1930 La Salle Street #203, the Airlan Arms Apartments, to check the welfare for Jepsy Kallungi DOB: 11/25/1992. The reporting party, Lalaine Leypold, placed the call from the state of Alaska stating she has not been able to contact Jepsy since March 20, 2019. Officers did not make contact with Jepsy. Officers spoke with management who stated Jepsy has not been seen in weeks. Ms. Leypold is a long-time friend of Jepsy Kallungi. They have known each other since high school. It is unusual for them not to talk on a regular basis. Ms. Leypold is concerned that Jepsy is injured or possibly deceased. While looking at premise history, of law enforcement contacts, officers saw

four separate Calls for Service dating back to March 28, 2019. During each Call for Service (CFS), no contact was made with Jepsy.

CSPD check the welfare calls to 1930 East LaSalle Street #203:

April 4, 2019 Call Screen 19147908 detailed Jepsy's husband, Dane Oliver Kallungi DOB: 12/23/1982 is former military and has access to weapons.

Officer Mathis responded to the most recent Call for Service. Officer Mathis spoke to the Reporting Party, Lalaine Leypold, by phone and learned Jepsy was recently separated from her husband. Ms. Leypold told Officer Mathis it is unusual for Jepsy to disappear without telling anyone as she frequently makes contact by phone and is active on Facebook. Jepsy has not posted on Facebook for the several weeks and has not made contact with family or friends.

Officer Mathis placed a phone call to Dane Kallungi to inquire about the whereabouts of Jepsy. Mr. Kallungi told Officer Mathis he was out of state visiting his father. Mr. Kallungi told Officer Mathis, Jepsy left on Wednesday March 27, 2019 to go visit a friend named Gina. Mr. Kallungi said he has not heard from Jepsy since. Mr. Kallungi stated he has no idea where Jepsy is because she left him due to marital problems. Officer Mathis said Mr. Kallungi was nervous during their conversation. Officer Mathis described Mr. Kallungi as being unconcerned about the whereabouts of his wife. Officer Mathis made multiple attempts to contact Jepsy by phone. Each attempt went directly to personalized voice mail with Jepsy identifying herself by name. Officer Mathis has received no return phone calls.

Officer Mathis again spoke with Ms. Leypold who told him Jepsy has a good friend named Gina Hanusiak in Chicago. Believing this Gina may be the person Mr. Kallungi was referring to, Officer Mathis obtained Ms. Hanusiak's phone number from Ms. Leypold. Officer Mathis called Ms. Hanusiak who told him she was not expecting Jepsy and has not spoken to Jepsy since March 20, 2019. Ms. Hanusiak told Officer Mathis Mr. Kallungi has made threats to impede Jepsy's efforts to gain U.S. citizenship in order to control her behavior.

Multiple friends of Jepsy called police on April 4, 2019 concerned for Jepsy's safety. One phone call was from Jepsy's mother in Hong Kong who mentioned possible domestic violence. Jepsy's mother also stated she has not heard from Jepsy in weeks, which is unusual.

On April 4, 2019, I contacted Lalaine Leypold by phone to get information about Jepsy to further this investigation. Ms. Leypold said Jepsy and Mr. Kallungi have argued on multiple occasions about the relationship between Mr. Kallungi and his ex-wife, Alaine Kallungi. Ms. Leypold explained Jepsy believed the relationship between her husband and her husband's ex-wife, with whom Mr. Kallungi has a young child, is inappropriate. Ms. Leypold said Mr. Kallungi left Jepsy for an extended period to stay with his ex-wife, leaving Jepsy alone in the apartment for about a week. Ms. Leypold said Jepsy did not have access to transportation or food during that week. Ms. Leypold said Jepsy threatened to report Mr. Kallungi to the police for abandoning her. This caused Mr. Kallungi to return home a short time later. Kallungi's ex-wife lives in Colorado Springs. Mr. Kallungi was known to see his child at least twice a week if not more often.

Ms. Leypold said Jepsy often contacted her by phone calls and text messages to talk about her ongoing marital problems. Ms. Leypold stated Mr. Kallungi and his ex-wife, Alaine Kallungi, had conversations about their relationship with each other. Ms. Leypold said Mr. Kallungi is in frequent contact with Alaine Kallungi and may have talked to her about his relationship with Jepsy. Ms. Leypold provided screenshots taken by Jepsy of an email from Mr. Kallungi to Alaine Kallungi. Mr. Kallungi is telling his ex-wife he will not give her his new home address. He tells Alaine "When we had our conversation about Jepsy moving here you got upset and said you would come over and make her talk to you if she wouldn't agree to it". Later in the same email, Mr. Kallungi says, "For the record what happened before with Jepsy and us this past(y) year or so was completely wrong". Later in the email Mr. Kallungi writes, "I have apologized for everything I did to her, and I feel terrible about it. You should be apologizing too instead of demanding a conversation with her again. Everyone makes mistakes in life, it doesn't have to be so hard to admit. The way you act about it now makes me wonder if it was a mistake for you at all or if it was intentional".

On April 4, 2019, Mr. Kallungi contacted the manager, Cynthia Gomez, of the Airlan Arms Apartments to ask how to break his lease effective immediately. I spoke to Ms. Gomez who said the Kallungis moved in March 1, 2019. Ms. Gomez told Mr. Kallungi, both he and Jepsy were required to be present when the lease was terminated. Mr. Kallungi stated Jepsy was unavailable to come into the office because she went home. Mr. Kallungi did not specifically give a location of where Jepsy's home is. It should be noted, with the assistance of an I.C.E. agent, I later learned Jepsy has no outbound activity from the United States.

April 4, 2019, I, along with other detectives, executed a Search Warrant for 1930 East La Salle Street #203. During the search of the aforementioned address, detectives saw no obvious signs of a crime scene. I noted the lack of female clothing or other belongings that would be associated with Jepsy. Detectives did find ammunition including 30.06-caliber, .45ACP-caliber, and 9mm luger. Additionally, a 30.06 rifle was found in the hallway closet and a .45 ACP pistol was found in a black backpack. A 9mm weapon was not located. Jepsy Kallungi was entered into CCIC/NCIC as a missing person on April 4, 2019.

On April 5, 2019, I contacted Dane Kallungi by phone. I asked where Jepsy was. Mr. Kallungi said he did not know. He said Jepsy met a Filipino female identified as Gina (last name unknown) at a Filipino restaurant in Colorado Springs called Julie's Kitchen. Mr. Kallungi said he did not know anything about Gina, nor did he have contact information. Mr. Kallungi said he and Jepsy got into an argument on Wednesday March 20, 2019. He said Jepsy "left him" between 11:00 PM and 12:00 AM (03/21/19) due to that argument. It should be noted Mr. Kallungi told Officer Mathis, Jepsy left on March 27, 2019. Mr. Kallungi said Jepsy went to stay with Gina whom she recently met at Julie's Kitchen in Colorado Springs. Mr. Kallungi said he did not follow Jepsy out of the apartment and did not see her meet with Gina. I asked Mr. Kallungi why he and Jepsy argued on March 20. Mr. Kallungi said he found text messages on Jepsy's phone between Jepsy and a person called Travis (unknown last). Mr. Kallungi said those messages appeared to be Jepsy and Travis planning to meet. Those text messages are not date stamped and nothing further was known about Travis' identity.

I asked Mr. Kallungi where he was. Mr. Kallungi said he was visiting his father. Through a records search I learned Mr. Kallungi's father lives in California. I asked him when he was returning to Colorado. Mr. Kallungi said he was planning to be in Colorado Springs Wednesday (April 10, 2019). I asked Mr. Kallungi if he would sit down for an interview when he got back to town. Mr. Kallungi's answer was ambiguous though he did not say no.

I asked Mr. Kallungi if Jepsy had a credit card or debit card in her name. Mr. Kallungi said Jepsy does have a debit card in the name of Jepsy Kallungi from U.S. Bank (bank account number unknown).

On April 9, 2019, I found Gina, who identified herself with the last name, Mayette DOB: 11/23/1965. Ms. Mayette said she did meet Jepsy at Julie's Kitchen on or about March 8, 2019. Ms. Mayette said she started speaking to Jepsy, who was with Dane Kallungi and Dane's son, because she recognized Jepsy had the same Filipino dialect. Ms. Mayette said she did exchange phone numbers with Jepsy though she did not exchange address information with Jepsy. Ms. Mayette said she sent a text message to Jepsy on March 17, 2019 inviting Jepsy to lunch. Ms. Mayette said Jepsy turned her down because she was busy. Ms. Mayette showed me three text messages. two of which were from Ms. Mayette to Jepsy and one reply from Jepsy to Ms. Mayette. Those text messages are in a Filipino language and Ms. Mayette translated. Ms. Mayette said this was the only communication with Jepsy since they met on March 8.

On April 10, 2019, I spoke with Airlan Arms Apartment Manager Cynthia Gomez a second time. Ms. Gomez said Mr. Kallungi contacted her and terminated his lease that same day. Mr. Kallungi told Ms. Gomez he might not return to Colorado for a possible time span of two months. Mr. Kallungi gave a forwarding address of _____ in Colorado Springs CO, which is the home of Mr. Kallungi's ex-wife, Alaine Kallungi.

On April 10, 2019, with the assistance of a Financial Crimes Detective who conducted a records search, I learned that Jepsy's debit card was last used on March 20, 2019 and posted on March 21, 2019 for \$44.99 using a "square" device. There does not appear to be any further transactions since that date.

On April 15, 2019, I spoke with Michael Poltenovage, who owns a small business in Colorado Springs. Dane Kallungi has been an employee of Mr. Poltenovage's for the past four years. Mr. Poltenovage's business is in making pet supplies. Kallungi essentially did "busy work" for him in deliveries etc. He said Mr. Kallungi contacted him between March 18 and 20, 2019 to ask for time off work. Mr. Kallungi told Mr. Poltenovage he needed to go to California to talk to his father and get advice about personal matters involving his relationship with Jepsy. Mr. Poltenovage was out of town on business at that time and agreed to give Mr. Kallungi the week off. Mr. Poltenovage said when he returned to Colorado Springs on March 24, 2019 he was surprised to learn Mr. Kallungi was still in California. Mr. Poltenovage spoke to Mr. Kallungi on April 1, 2019 and learned Mr. Kallungi planned to stay in California indefinitely.

Mr. Poltenovage said Mr. Kallungi is still working for him on a part time basis from California and he is still in regular contact with Mr. Kallungi. He said he asked Mr. Kallungi where Jepsy is and Mr. Kallungi said he did not know. Mr. Kallungi told Mr. Poltenovage, Jepsy wanted to go back to Chicago then return to the Philippines. Mr. Poltenovage said he did not understand that because “she seemed to be doing everything in her power to stay in the United States.”

Mr. Poltenovage said a black Toyota Supra belonging to Mr. Kallungi has been parked in the lot at his business for the past two weeks though Mr. Poltenovage could give no explanation why. Mr. Poltenovage said Mr. Kallungi owns a second car and a motorcycle but did not know where those vehicles were. Mr. Poltenovage confirmed the phone number he is currently using to contact Mr. Kallungi with is 719-684-5962.

On April 16, 2019, I reviewed Call Detail Records (CDR) belonging to two separate phone numbers registered to Dane Kallungi, 719-684-5962 (T-Mobile) and 719-761-4070 (Sprint). Both of these phone numbers are active and being used. CDR records show Mr. Kallungi, if in the possession of these phones, are in the following notable locations:

- San Diego International Airport **04/01/19 17:31 hours**
- San Diego International Airport **04/06/19 13:29 hours**
- Denver Colorado **04/06/19 18:24 hours**
- Colorado Springs Colorado **04/06/19 22:40 hours** (in the area of E. Rockrimmon Boulevard and Interstate 25.
- **04/07/19 00:40 hours to 04/08/19** CDRs move west through Colorado to San Diego California. Showing Mr. Kallungi driving back to California.

On April 17, 2019, Detective McLain spoke with Daniel Garcia, a co-worker with Dane Kallungi. Mr. Garcia told Detective McLain he began working for Mr. Poltenovage in February of 2019. Mr. Garcia said he convinced Mr. Kallungi to join a gym called VASA Fitness and start working out. Mr. Kallungi did join the gym but he and Mr. Garcia did not work out together. Mr. Garcia said, during the week of March 18, 2019, Mr. Kallungi began sleeping in his car during lunch break, even though Mr. Kallungi lived a short distance away. Mr. Garcia said he noticed Mr. Kallungi seemed to stop eating during the week of March 25, 2019. Mr. Garcia said he received a text message from Mr. Kallungi on Saturday March 30, 2019 in which Mr. Kallungi said he would not be going to the gym that day. Mr. Garcia said that was strange because the two did not work out together. Mr. Kallungi sent a second text message telling Mr. Garcia he was going to Buena Vista to visit his mother instead. During that conversation, Mr. Kallungi told Mr. Garcia he took Jepsy, as a guest, to VASA Fitness on March 23, 2019 or March 24, 2019. Mr. Garcia said Jepsy did a leg workout and she had sore muscles.

Mr. Garcia arranged to meet Mr. Kallungi at their work place, 2833 N. El Paso Street, on Sunday March 31, 2019. The purpose was for Mr. Kallungi to train Mr. Garcia on work related activities. When Mr. Kallungi arrived, he apologized for being late explaining he and his son fell asleep in Woodland Park, Colorado during their trip back from Buena Vista. Mr. Garcia said that sounded odd because the trip from Buena Vista to Colorado Springs is only three hours. On that same day, Mr. Kallungi told Mr. Garcia he was going to California for one week to visit his father. Mr. Garcia said while he and Mr. Kallungi were still at 2833 N. El Paso Street, Mr. Kallungi called his ex-wife, Alaine Kallungi, to come pick up their son because Mr. Kallungi was not going back to his apartment.

Detective McLain confirmed with Mr. Garcia that Mr. Kallungi's black Toyota Supra was parked in the lot at 2833 N. El Paso Street. Mr. Garcia said Mr. Kallungi was driving his red Mazda on March 31.

On April 18, 2019, I reviewed phone record data for _____, the confirmed phone number registered to Jepsy Kallungi. Mr. Kallungi stated Jepsy left him on March 20, 2019 between 2300 hours and 0000 hours on March 21, 2019 and took her phone with her. When subscriber data for Jepsy's Verizon account was received there was limited Cell Site Detail. However, there are notable cell tower connections made between March 20, 2019 and March 23, 2019. Call Detail Records for Jepsy's cell phone show the following:

- **March 20, 2019 at 03:32 hours**, LTE Records show Jepsy's cell phone connects to the cell tower 016877 in the area of 1930 E. La Salle Street, the Airlan Arms apartment complex.
- **March 20, 2019 at 22:30 hours**, Jepsy's cell phone makes a 911 call/hang up. This is the last known outgoing phone call from Jepsy's cell phone.
- **March 21, 2019 at 22:14 hours**, Multiple I.P. connections from Jepsy's cell phone to tower 16273 show Jepsy's phone in the area of Cripple Creek. During this period, no family or friends of Jepsy have been in contact with her. There has been no reported contact with Jepsy since March 20, 2019. As stated previously, Mr. Kallungi's cell phone connected to a cell tower in the area of Woodland Park Colorado on **03/21/19 at 21:09 hours**.
- **March 22, 2019 at 01:30 hours**, LTE Records show Jepsy's cell phone connects to tower 273 in the Cripple Creek, Colorado area. This is only a tower connection not a voice call.
- **March 23, 2019 05:11 hours**, Jepsy's cell phone connects to the cell tower near 1930 E. LaSalle Street.
- **March 25, 2019 from 22:04 hours until 22:07 hours**, Jepsy's cell phone makes I.P. connections to a cell tower in the area of North Academy Boulevard and North Union Boulevard in Colorado Springs. It appears Jepsy's phone was powered on briefly and it downloaded four incoming messages. The content and origin of these messages is unknown. I would note, Dane Kallungi's cell phone connected to a tower near this same area, approximately 20 minutes after Jepsy's phone powered on and received those messages.

On April 19, 2019, I went to VASA Fitness, 455 East Cheyenne Mountain Boulevard and received membership records from staff concerning Dane Kallungi. Records show Mr. Kallungi did go to VASA Fitness on March 23, 2019 at 1738 hours, and that he went alone. Records show Mr. Kallungi took Jepsy to VASA Fitness one time only. The date Mr. Kallungi took Jepsy to VASA Fitness is March 16, 2019 at 1636 hours. Furthermore, records show Mr. Kallungi cancelled his membership to VASA Fitness on April 15, 2019.

On April 19, 2019, Alaine Kallungi came to the Police Operation Center where she agreed to be interviewed by Detective Bichel. Ms. Kallungi told Detective Bichel she was still in regular contact with Dane Kallungi and was in contact with him earlier this same day. Ms. Kallungi said Dane was scheduled to return from California on April 9, 2019. Mr. Kallungi told Ms. Kallungi he flew back to Colorado two days early (April 7) to talk to detectives. When Mr. Kallungi found that his apartment had been searched, he got "spooked" and immediately gathered his belongings, including the two firearms remaining inside his apartment, the Tikka 30.06 Rifle Model M695, and a Hi-Point Model JMP .45 ACP caliber pistol. Mr. Kallungi drove back to California in his red Mazda sedan. Mr. Kallungi told his ex-wife he planned to stay in California permanently.

On April 21, 2019, Daniel Fernandez, an Army Sergeant stationed at Fort Carson, spoke to Officer K. Mowery at the CSPD Police Operation Center. Sgt. Fernandez said he had an ongoing sexual relationship with Jepsy dating back to 2017. Sgt. Fernandez told Officer Mowery he last saw Jepsy on March 15, 2019. Sgt. Fernandez showed Officer Mowery a text message from Jepsy, time stamped Friday March 15, 2019, 1935 hours, giving him her address of 1930 E. LaSalle Street. Sgt. Fernandez said he picked Jepsy up then later dropped her off at 1930 E. LaSalle on March 15, 2019. Sgt. Fernandez told Officer Mowery the reason he came to the Police Operation Center was to report what he believes is the suspicious behavior of another Army soldier at Fort Carson identified as Travis DuFour. Sgt. Fernandez said Mr. DuFour has “liked” numerous Facebook pictures of Jepsy. Sgt. Fernandez said he contacted a friend named Skylur Beardsley on Instagram, who told him Travis DuFour was “bad news” and that he threatened her in the past. The nature of those threats were not described.

On April 23, 2019, Travis DuFour came to the Police Operation Center where he was interviewed by Detective McLain. During the interview, Mr. DuFour stated he had an ongoing sexual relationship with Jepsy Kallungi for about one year. Mr. DuFour said Jepsy was with him on March 20, 2019, at which time the two did become intimate with each other. Mr. DuFour stated he picked Jepsy up at her apartment complex, 1930 E. LaSalle Street, on the afternoon of March 20, 2019 then drove her to his barracks at Fort Carson. Records show Mr. DuFour checked Jepsy into his barracks at 17:21 hours on March 20, 2019. Additionally Records show Mr. DuFour checked Jepsy out of his barracks at 21:11 hours on March 20, 2019. Mr. DuFour said he drove Jepsy straight back to 1930 E. LaSalle Street, where he dropped Jepsy off. Mr. DuFour said he did not go inside Jepsy’s apartment.

Jepsy’s Facebook records show messages from Jepsy to Mr. Kallungi stating Jepsy was going to be at Gina’s (Mayette) earlier on March 20, 2019. Facts of this investigation show Jepsy was with Travis DuFour at Fort Carson during the time Mr. Kallungi was told she would be with Gina. This information confirms the possibility Mr. Kallungi and Jepsy were arguing about Travis on the night of Jepsy’s disappearance.

On April 23, 2019, while reviewing data from Jepsy’s Verizon account, _____ I found two incoming voice calls from 719-444-7000 (Colorado Springs Police Department) at 22:31 hour and 22:32 hours. CSPD Call Screen 19125444 documents a 911 cell hang up at 22:30 hours on March 20, 2019. The location of the placed call is unknown and referred to as “1 cell rd.” Due to the unknown location, no officers were dispatched. I located an outgoing call record, on Jepsy’s Verizon account, showing Jepsy’s phone calling “urn:service:sos:” (911) at

22:29:50 hours on March 20, 2019. This appears to be how a 911 hang-up call is detailed by the phone company. This appears to be the last outgoing phone call made by Jepsy's cell phone.

Alaine Kallungi identified Ronald Kallungi as the father of Dane Kallungi. During Alaine's phone contact with Dane, she learned he is currently staying with his father, Ronald Kallungi. Detective Joines searched law enforcement databases for Ronald Kallungi and found two possible addresses for him that looked recent. The first was _____, San Jose, CA 95123 that listed current up to April 3, 2019 and the other was _____, San Diego, CA 92107 that listed current up to April 18, 2019.

I checked Call Detail Records attached to Dane Kallungi and found Mr. Kallungi's phone records showed him in same area as _____. Detective Joines contacted the San Diego, CA police department on April 19, 2019 to request someone check that address for Dane Kallungi's car, a red Mazda sedan bearing Colorado license plate _____. A patrol officer did locate Dane Kallungi's red Mazda sedan bearing Colorado License plate _____ parked in close proximity to _____.

On April 26, 2019, I travelled to San Diego California where I executed a Search Warrant on _____. I collected cell phones and laptop computers, among other items, belonging to Dane Kallungi from the residence. At the completion of the search, I conducted a Mirandized interview with Mr. Kallungi. During the interview, Mr. Kallungi repeated the story he told me on April 5, 2019. When I confronted Mr. Kallungi about both Jepsy's cell phone and his cell phone connecting to cell towers in the Cripple Creek area, Mr. Kallungi invoked his Fifth Amendment Rights.

On April 26, 2019, Detective Bichel spoke to Alaine Kallungi a second time regarding her past 15 years with Dane Kallungi. During this interview, Alaine spoke of multiple incidents of Domestic Violence, dating back to 2006, in which Mr. Kallungi strangled her. One of those incidents is documented under CSPD call for service 1523989 from 2015. Alaine described the 2015 incident saying Mr. Kallungi put his left hand on her throat and strangled her while pushing her into a wall.

Alaine told Detective Bichel that Mr. Kallungi strangled her five to seven separate times. On more than one occasion, Alaine lost consciousness from 30 seconds to one minute. Alaine said Mr. Kallungi used two hands

when he strangled her unless he needed to hold her down with a free hand. Alaine described an incident when Mr. Kallungi picked her up in the air by her throat.

On May 1, 2019, Detective Bichel interviewed Alison Myers DOB: 02/03/1989, the twin sister of Alaine Kallungi. During this interview, Ms. Myers stated she witnessed the incident, in 2007, when Mr. Kallungi picked Alaine up in the air by her throat. Ms. Myers was living with Alaine and Mr. Kallungi at the time and described an argument between the two in which Mr. Kallungi blocked the doorway preventing Alaine from leaving. Ms. Myers said the argument turned physical when Mr. Kallungi grabbed Alaine by the throat, lifted her six inches off the floor, and pushed her into the doorjamb. Ms. Myers said Mr. Kallungi threw Alaine to the side like a rag doll after strangling her. Ms. Myers told Detective Bichel she was the person Alaine called in 2015. Ms. Myers said she immediately went to Alaine and saw the marks on her neck from being strangled by Mr. Kallungi.

On March 23, 2021, I received a phone call from Alaine Kallungi, who told me Dane was going to be in Colorado Springs from March 25 - March 28, 2021 due to an illness in his family. Alaine said that Dane asked her, through email, if the two could get together and talk while he was in town.

On March 26, 2021, Dane Kallungi and Alain Kallungi ate lunch together in a Colorado Springs restaurant. During that conversation, Dane told his ex-wife that he killed Jepsy Kallungi.

On March 29, 2021, Alaine Kallungi contacted me to tell me what she learned from Dane. Due to this new information, detectives arranged for Alaine to do a pretext phone call with Dane.

On April 3, 2021, With Alaine's consent, she engaged Dane Kallungi in a pretext phone call. I was present and recorded the conversation between Alaine and Dane. During that phone call, Dane gave details about a disturbance between himself and Jepsy on March 20, 2019. Dane made the following statements:

"I kind of like, I grabbed her and I guess it was just like a second where I got pissed off, but I didn't even feel that pissed off. It was like I just turned around and was like shut up and I was sick of it and I mean really, I was just was trying to like literally stop the words from coming out of her mouth for a second and then I realized that I did that for more than a second and..."

“It looked like I did some damage and I freaked out and it looked like she was suffering.”

”Yeah, that’s the part I think about still. It’s, looking at her eyes, you know.”

”It was like, you know, I used to think about killing terrorists and it was like I don’t know. I didn’t want to kill some little girl. I wanted to kill terrorists.”

“Yeah. I was, I wasn’t sure if I had already like killed her and it was like the stuff you see in the movies about how people die. That is so not even how it happens.”

“I was thinking about that and I was also thinking about like what, you know, is she going to go to the hospital and...”

“Like she was already dead. It was just a matter of time and like I didn’t want to watch her suffer anymore, but I didn’t want to keep doing that and it was all just really bizarre because I mean it was like she was on the floor.”

“I put her on the floor and it was like there was still some kind of breathing going on even though she was gone and I just, just regretted that.”

“And no matter how much I tell myself that I didn’t mean to or she was doing this and she was doing that and she was like, you told me she was like basically a prostitute and I was like it doesn’t matter. She still didn’t deserve it.”

”I don’t even remember the exact details. I kind of got lost. I had her wrapped up in my car, in the trunk and...I know, it’s like...”

“Yeah, it’s freaking weird, like sometimes I’m still going up, I can’t believe I did that and I’m like there’s no way I did that, but I did do that. So yeah, I drove to the like Florissant area... on back road, got lost on like four different back roads and then found one where I could, I just went down and found a spot, dug a hole as deep as I could.”

"I was digging until like 3 in the morning or something because it was like all muddy and really hard to dig in some places and I started freaking out. I'm like oh my gosh people are going to start driving through here because it's not middle of the night anymore so..."

"Yeah, she was in my trunk and then after work I drove to Florissant and found a spot and like I just stuffed her and...hold on a second...yeah, I went to Florissant and no, I like said good bye to her before I put her in there and tried to apologize a million times."

In Summary, information gathered during this investigation suggests that Dane Kallungi strangled Jepsy Kallungi, during an act of domestic violence, causing her to be severely injured. He saw that Jepsy was "suffering" which caused him to facilitate her death by his own hand. This incident occurred on March 20, 2019 inside apartment #203 at the Airlan Arms Apartment complex, 1930 East La Salle Street, at or about 10:30 PM. Dane Kallungi then placed Jepsy Kallungi's body into the trunk of his vehicle, took his son to school the following morning, then went to work. After work, Dane took Jepsy's body to a remote area in Teller County where he buried her in a clandestine grave. Dane then moved to San Diego California, avoiding cooperation with this investigation.
