Welp! apparently, you have women who like have the hots for you?! I'd steer FAR from them. That's just sick and if they're acting like they want you, they're just hoping you have money OR will put them on the map.

Anyways. so, I got locked up 10 years ago. I started on oxy 80s after a broken femur and after a few years ended up on heroin. After being caught, twice, for selling it I got a subsequent offense and was given 2 years. I did 18 months and got out on the bracelet. People say I look like a beauty queen contestant but I'm tough and came up tough so I held my own in there (I was in the Massachusetts prison for women). I think, often, about your state of mind in there. it's a lonely place and you've lost 2 of the most important people. I pray Buster is able to make some peace with all of this.

Turns out I know someone who knows your family well. he's a mass chicken poultry farmer with 15 chicken houses; [REDACTED] SC, Jackson West.

maybe if we become pen pals I can visit you one day I know how important visits are in there and how it really helps to sort of take you out of that place for a little bit.

BTW they're literally posting people's mail to you on the news.....how is that legal?!

well, I hope you're getting acclimated well to the new facility, the best you can anyways. Welp! I'm gonna get my day started. I was compared to Jessica Biel yesterday at the gym.....what a compliment, she's so athletic and fit!...and a beauty, of course!!! I HATE this app.....this is the worst app for jails. you can't go up and edit anything without it acting all wonky. so I'll leave my letter like this I guess but I was saying I'm getting my day started and going to the gym and then brought up Jessica biel and now I feel like it looks like I just brought it up for no reason haha! Welp, have a good day and keep your head up! Make sure you're praying to God. No matter what happens at all, God is with you and loves you.
