Dear Judge Dorow:

Enclosed is a packet of 37 pages that are dated November 22 and were received by the Waukesha County Sheriff's Department on November 26, 2023. This packet of papers is comprised of Ms. Kurczewski's initial letter to the recipient followed by many pages of instructions whereby Ms. Kurczewski asks and instructs the recipient how to create fraudulent documents along with a fraudulent cassette tape recording. The recipient received this packet of papers at her home and was disturbed by what Ms. Kurczewski was asking of her, and ultimately, the recipient decided to turn them over to law enforcement.

The State wishes to point out that the original paperwork was double sided which is important to note as Your Honor reads through the papers because Ms. Kurczewski's substantive instructions were written on the back of her own trial note pages from the recent trial held between October 23 and November 14, 2023. For example, pages 17 and 18 of this packet are the same but for the exception of a post-it note Ms. Kurczewski utilized as a means of showing the recipient where the recipient should place a fraudulent copy of a notary stamp on that document. Page 19 then is the reverse side of that same sheet of paper and contains Ms. Kurczewski's notes taken during trial. The same is true of pages 20 and 21 being the same but for Ms. Kurczewski's instructions on where to place a fraudulent notary stamp

and page 22 being the reverse side of that paper containing Ms. Kurczewski's trial notes. This pattern continues throughout the remainder of the 37 pages. This is important to note because Ms. Kurczewski has now written new fraudulent letters purporting to be from Lynn Hernan dated in 2016 and 2017 on the back of her paperwork from trial which obviously occurred in 2023.

These have all previously been provided to Ms. Kurczewski's attorneys.




I wanted to thank you for being a friend through this crap, I mean that. Some days I feel so alone and now even more so. I feel very selfish lately and I hope<sup>d</sup> told you I'm sorry for your loss, your brother. I haven't asked either how your doing, or your kids - I hope all is well! I appreciate you coming for court and both your friends, please tell them too. I dk jess, this is just insane to me. I sit here day in, day out reliving and replaying everything. I cannot spend the rest of my life locked away for something I didn't do - this isn't right. I wish I had the jury names, I so want to reach out, I'm losing my mind about this. If I'm honest I don't know how much more I can take, I've waited four and a half years for this to be made right and it got ten times worse not better. I don't want to be here anymore. I'm so strong in my faith but right now I can't even open my bible, I don't understand. I can't go a day without breaking down at my new reality, staring at these walls. I keep thinking of all the things I want ever do or have, the hardest ones is not being able to see my grandparents before they pass and not being able to have kids. I'm glad I don't with all this but by far that's one I get super emotional about, its what I always wanted. Then theres my mom I worry about

Shes got nobody left, she would have taken her life long ago but I needed her. Shes struggling with all of this and blaming herself cause she couldnt deal with Lynn anymore so I stepped up to help Lynn daily when she stopped and because she couldnt testify. We had a pact if things went wrong like this, we were both checking out. Im trying to fight and hang on but its so hard, I feel Im fighting a lost cause this county is so crooked, its not even funny. You should see just what Ive uncovered in Discovery since trial ended that they lied on the stand about, its so wrong. So I talked with one of my attorneys about stubb in person and I got a biggie for you - to ask of you. First of this is big, I trust you and whether you help or not this is something I need you to take to your grave. Even this envelope didnt go out through jail mail, my attorney took it. This was one of my attorneys ideas and clearly they arent going to tell anyone, I will never tell a soul, you can tell someone if its to ask for help only if you trust them and if you arent comfortable Im going to give you another persons address and send it to them w/ directions please. Either way do not talk about it on phone or visit. You can say I got your letter, if you can do it just say yes I want you to send me a writing form when you get to

TCI and if not then say you need that address for my friend and I'll figure out who plan B is and give you a name & address to forward it too. I know that all sounds cryptic (sp?) cause it is! lol we are trying to make a stir, a big stir to show just how wrong things are. But I need help cause theres only so much I can do in here. First, you need to know I did not kill Lynn nor did I assist nor did I ever steal a dime from her - ever. My old charges are that old, dumb, young.

This is what I need -

Do you remember hearing about the park, Whitnall park? Where it buried things? That was 100% true the difference is 6 months later or so I regularly went on walk there, daily. That area was prone to flooding and the bag was sticking out one day, so I dug it out and ended up throwing away - only 1 person knows that, my attorney. Everyone else believes its in the park or never was. It was part of the gun, vials bottles (Lynn had dated from her moms death - I never told anyone that,) notarized papers of hers and a cassette (sp?) tape old school voice reading of Lynn - All confession stuff that I kept hidden and quiet. I dont know if I ever told you about Lynns mom or if you heard when Dona tried to bring it up in court and the judge shot it down. The state requested her moms records but never turned them over. While I was in prison in 2013 Lynns mom died, she gave her vials in her tea when she cut her out of her will when she found out (her mom) she was stealing her money - her mom died, she got dizzy and fell down stairs, no autopsy was done. But she was always afraid, I didnt know this til after Lynns passing thats why she gave money away it haunted her. Also how and why she started drinking it. First was to die but it didnt happen she had been drinking for months (I didnt know til the end) but it numbed her pain and helped her sleep, she

was an insomniac and Zanax wasn't helping her to sleep anymore. Ok, sorry it's complicated yes and I'm at blame because I didn't save the stuff but at the time what did I need it for and I didn't want anyone knowing what I found out. So here's what I'm trying to do, recreate that stuff. I did what I could. I wrote up the letters, will, etc and I signed all names, dates, etc. I need someone to look online for a notary stamp - not to buy, there are places that will show you finished product, you input name or what it should say and you can copy and paste - you may need to look at a few but they have when you can view sample. Then you take the pages I wrote, copy them a few times, make a little lighter, then line ~~up~~ up for notary and print more notary around angle turn so forth so it's not lined up perfectly - make it look good, yes I used to make documents for people - sounds crazy but true I was good at it, those bank ones were Lynns doing I didn't make those mistakes. Anyway sorry, then ~~copy~~ when done copy the whole page again so it's a full copy not original so nobody knows the notary seal wasn't a real stamp. All I need is two different names for notary, 1 on 1 page and the other 1 on 3 pages. These are real people, who worked at her bank years ago, who actually notarized papers on these set dates and I have those

Other papers here w/ the signature, dates, all that's how I did this. I just need the notary and copies, please. Explained with the pages -

Now theres one more part I am trying to get with that. I cant do anything on the urine bottles cause, those bottles are way to old that none in stores would match and the gun piece they know she had & bought so it doesnt matter. Its the cassette tape, I need to see if someone would make a voice tape. I know this is crazy but I gotta try, its worth it cause its my life & if I could I would. They would suspect my man thats why I cant have her. Nobody has her on voice recording, she has an older, raspy, smokers cough and was sick, female voice. Always coughing and smoking. I feel like theres programs online to change voices - theres so much technology these days, she was sick and did it 2 days before her death nobodys going to know if its her or not, its been 5 years. And I have the wording for that recording. Honestly you could even have a movie or music on in the back ground to help distract. She always had one on and loud - I would just be cautious that its music (she loved Gaga) or a movie from before her death if you do that, so it doesnt raise a red flag. Like pretty women, Ms. Doubt fire, Wizard of Oz - would be ideal, her favorite!



## Tape Recording to record

Jessy, I am sorry to leave you like this and I'm assuming you'll be the one to find me after all you have done for me all the times you saved my life. I know if it wasn't for you I would have been dead months ago you have been my rock, your stronger than anyone I know and now I need you to take care of your mom for I know you did all you could to keep me alive as long as you could. I no longer recognize myself I'm sick of being sick complaining about being sick and just sick of it all. I want to be free from the pain and this is my time. I love you and your mom very much, take care of each other. I'm following the yellow brick road to see my dad. Jessy stop listening to this tape and put it somewhere safe and hidden.

Lynn Hernan Being of sound mind and body want to state I'm recording this statement today on Sunday October 1st, 2018. I have been sick long enough, seen enough doctors to know that I will never be the same and I no longer want to live my life as it is. I have done things I cannot take back, I took a life that I had no right to do. I am choosing on my own free will and on my own time frame to take my own life. I have tried more options than most from purchasing a gun, over use of medications to poisons, I assumed poisons would be the fastest and easiest little did I know it would be just as hard. Visine is one I stumbled across prior and tried without success but ended up using it not for almost 3 months. The way it makes me feel is something undescrivable my body is numb I feel no pain from my constant pain and it makes me tired where I sleep a kind of sleep I havent experienced in years

I became quite fond of it, it was a new medication to me. I enjoy my medications and now vicine is one of them. At first I was drinking a bottle almost daily mixed in my water or vodka then I increased over time, was purchasing vicine on my own for over a month until I could no longer drive or shop. I did stock up on it and had my caretaker Jessy she did not know what I was doing until recent. Jessy is the one person who knows everything I have went through in and out (except my mother's death) seen all the good and bad she has been there when I fell in the middle of the night shit on myself or puked and came to clean it up she has caught me in the act of trying to take my own life she has seen me at my worst and there regardless. I owe her everything for all she has done. Her mother my best friend and Jessy are my ~~only~~ only family left and mean more than they know. I did the unthinkable to Jessy and it ruined her for months I lied to her and I had her lie to everyone in the process and it destroyed her. She knew I was suicidal but I told her I was sick and dying from colon cancer. I didn't want to see people or talk to them so I had Jessy lie to everyone and I didn't want anyone to know. Truth was I wasn't sick with colon cancer or dying. One afternoon Jessy came to check on me as her usual and caught me with ~~a~~ unexpectedly while I had a gun to my head. She screamed at me crying that when I came clean with her about not having cancer and lying. I lied to her cause she was concerned about me being suicidal that saying I was sick was easier to do. I never seen her so hurt so lied to everyone she knew and didn't know what to do now. She told me that I was either going to get help and go to the hospital or she was calling the cops. I let her take me to

Aurora Waukesha Hospital the next morning where they admitted me and I stayed for weeks. I wanted to get better for her but deep down my decision was made long ago and I cannot go on anymore my moms death haunts me daily. I tried to take my life twice while in the hospital and had a camera pht ~~in~~ in my room. After arriving home from the hospital Jessy stayed the weekend and per my discharge I was to get in home care that week. I had planned in different ideas but Jessy ~~wasn't~~ <sup>didn't</sup> leave me alone ending the weekend came and went and now its today Sunday morning I took my remaining visine bottles and put them into my last water bottles, I have stashed visine for months and been emptying it over time to water bottles and now have 3 bottles full with only visine over 30 bottles and will start drinking those tomorrow along with my medications, I am hoping by drinking an extreme amount that this will work as planned. I am choosing this on my own terms and how I see fit no one played any part in this decision or acted in it. I chose to drink visine and end my life, look into my moms death to better understand. I came into this world fighting like hell and lived a good life and I'm going out of the world on my own terms soon I will see my dad again. I would like it known that Jessy and Jenny are in charge of my final wishes they know where the paperwork is and what to do. I want to make sure it is known —

I would print copies of letters many 1st then more stamp around and line up on plain sheet 1st then use copy of page - when done w/ notary copy page again so full page w/ notary is a copy and make copy for everyone plus if you could mail me nope never mind you need a address to mail me something and when you write everyone dont use any return address this is all by concerned citizen, its easier so your not involved, yes attorney said someone could use themselves if they want but thats too much to ask anyone easier anonymous I think I dont want them causing problems for anyone. Cause they wont be happy cause the bank people already said they did multiple notary pages and they are there's, they knew there was many not all turned in to court.


