Access to the API is limited to registered users who have accepted all relevant terms and conditions and opened an account with Composer or its affiliates.
- 2. Permitted Use: The API and related materials are provided solely for your personal use in connection with your own accounts. You may not distribute, sublicense, or make the API or any part of the Composer platform available to third parties. Use of the API is subject to compliance with all applicable agreements, including but not limited to Composer's Customer Agreement, Terms of Use, and other referenced agreements.
- Fees and Costs: You are responsible for all trading, account, and administrative fees associated with your accounts, as described in Composer's <u>Fee Schedule</u>.
