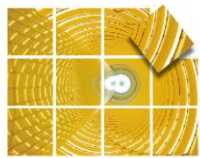

## ◆ Ceramic Tile & Decoration Materials

Stone materials, stone, and mining products; ceramic tiles, interior and exterior decorative building materials.

## ◆ Door, Window Hardware & Intelligent Building

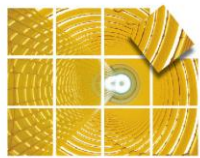
All kinds of doors and windows, hardware accessories, locks, handles and other related materials and Intelligent buildings, environment control system, intelligent parking system, etc.

## Qualifications:

1. Domestic or overseas manufacturers, traders, service trade companies or inventors that have been duly registered.
  - a. Qualification for displaying products made in Taiwan:  
Companies registered in Taiwan dealing with relevant products or services.
  - b. Qualification for displaying products from abroad:  
Foreign companies export to Taiwan permitting by Taiwan government or their agent, distributor, branch, or liaison office in Taiwan. Agent in Taiwan must present the letter of authorization or the contract to the show organizer.
2. Exhibitors should not transfer the booth or present different company name during the show. Different companies are not allowed to register together. If there is any violation, the show organizer has the right to expel the exhibitor from the show immediately. All paid money will thus be confiscated.
3. **If distributors put on display together, the registration company should provide the distributor list (name of distributors and contact information) before “Booth Allocation Meeting”.** The overall design of booths must be consistent with the registration company.

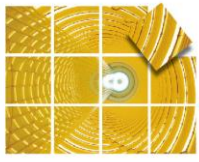
4. Exhibit jointly in a Pavilion, or as a group (agency):
  - a. Registration and approval from the show organizer is required, and no designated space will be allowed.
  - b. Booth allocation will be based on product features and the booth number.
  - c. **Exhibitors are required to inform and discuss with the show organizer before the end of May.**
5. Infringement on property right, counterfeit, knockoffs, or any other unlawful practices are not permitted. Exhibitor being accused of such and proved to be true will be expelled from the exhibition and should be liable for any legal responsibilities that may cause. All paid money will not be refunded.
6. Products that are unrelated to the show, or do not consistent with the products listed on the application form or violate exhibition regulations will not be permitted to put on display, all paid money will thus be confiscated.

## Regulations:

1. Registration for the 2024 Taipei Building Show will open on February 20.
2. Each booth area is 3m (length) × 3m (width). Please submit the following documents to complete the application:
  - ◆ **Booth Fee**
  - ◆ **Application Form**
  - ◆ **Relative Documents** (e.g. authorization letter, green building label...etc.)
  - ◆ **Product Catalog**  
Please provide an online profile or e-product catalog through email.
  - ◆ **Business Card**
3. The show organizer has the right to accept or deny the application to assuring the show quality.

## Booth Fee:

1. Raw Space Booth: **USD 1,800 each**, exhibitor is responsible for booth decoration as no partitions or equipment are provided.
2. Standard Booth: **USD 1,900 each**, including a carpet, fascia name board, desk, two chairs, three partition walls, three projecting lights, and a 110v electrical socket.

### 3. Additional Fee:

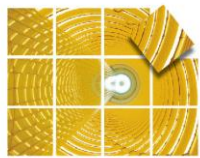
- a. **Booths next to a 6-meter aisle** (USD 100 each):  
Booths positioned adjacent to a 6-meter aisle **please complete the payment after the booth location confirmed.**
- b. **Double-deck Booth** (50% of total booth fee):  
Certificated by architect is necessary and booth layout should be submitted for approval.
- c. **Booth height over 4 meters:**  
Booth layout should be submitted for approval.
- d. **Continuity Walling** (USD 500/per meter):  
Submit booth designing layout before exhibit. Charge will be determined by the final construction in the exhibition.
- e. **Promotion Balloon Installation** (USD 500 each):  
Balloon must remain in the range of booth.

### Hall & Booth Allocation:

1. Once the venue is out of booth, please remain on the waiting list and wait for the notification from Organizer.
2. Organizer will arrange the suitable show area for your exhibits.
3. The show organizer will notify exhibitors who complete the registration via mail to attend the “Booth Allocation Meeting”. The principles of choosing booth are listed as below:
  - a. The regulation of selecting booth is based on the show area, the number of booth and the order of signing up. (Cross-aisle booths are not allowed)
  - b. **If exhibitors could not attend the “Booth Allocation Meeting”, the show organizer will allocate booth and no objection is allowed.**
  - c. Booth-sharing and booth-sublease are forbidden.

### Booth Cancellation:

1. If the exhibition is postponed or shortened due to force majeure factors, such as strike, natural disasters, epidemic situation, etc., the exhibitor shall not ask the organizer for compensation or refund. If the exhibition is cancelled, the necessary expenses will be deducted, and the refund will be given to the exhibitor. The organizer shall not be liable for the derivative expenses of the exhibitor.



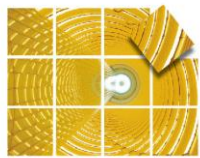
2. **If the exhibitor unable to take part in the show or cuts the number of booths after the registration, please notify the show organizer by e-mail two weeks before the “Booth Allocation Meeting”.** Deposit will not be refunded, and the balance will be refunded.
3. **After the “Booth Allocation Meeting”, the booth fee will not be refunded under any circumstance.**

## **Booth Decoration:**

1. During move-in and removal period, for products weighting under 2.5t and 150cm, loading and unloading forklift service is available; for any other special requirements, please fill out the application form and contact the service provider inquiring about the charge directly.
2. For double-deck booth or booth height over 4 meters, booth layout should be submitted for approval, additional fee should be charged.
3. Owing to the limitation of Exhibition Hall, extra electrical sockets and 220V power should be applied in advance and follow the related regulations.
4. If there will be any extremely large and heavy exhibits on display, please inform the show organizer in advance for arranging in an appropriate show area.
5. To maintain air quality, please do not decorate any materials expelling toxic vapors.
6. In the case of booths along the aisle, the length of the walls shall not be longer than 50% of their length along the aisle. In addition, the length of any continuous sealed wall shall not exceed 9 meters.

If it exceeds, the additional fee will be provided according to the design drawing, and charge will be determined by the final construction in the exhibition.

7. Install the air-conditioning equipment in the venue is prohibited. Besides, display the air-conditioning equipment cannot turn on the compressor.
8. After exhibition, exhibitors should ask the contractor to clean away all exhibits and decoration materials.
9. Please arrange the cleaning company in advance. Especially the foreign exhibitors who do not assign the domestic contractor. Please keep the work area clean during the exhibition.
10. Exhibits including ceramic tiles, glass, and stone products are not allowed to be smashed in the Exhibition Hall. Please maintain the integrity and recycle the exhibits.
11. The standard booth equipment is provided for rent. If the equipment is damaged due to improper use, it shall be liable for compensation.
12. Booth construction should abide by the rules set up by the Exhibition Hall, otherwise show management has right to dismantle all decorations and charge the additional fee.
