

# General Regulations for Visitors at TAITRA's Taiwan International Trade Shows

General Provisions	<ol style="list-style-type: none"> <li>1. These Rules are established by the Taiwan External Trade Development Council (hereinafter referred to as the "Organizer")</li> <li>2. The Organizer shall have sole authority to determine, interpret, and enforce whether any conduct of visitors during the exhibition complies with or violates these Rules, and no objection shall be raised.</li> <li>3. These Rules shall be published on the official exhibition website for visitors' review and printing. Visitors may not claim exemption from these Rules on the grounds of failure to review such content, lack of individual notice, or any other reason.</li> <li>4. The Organizer reserves the right to amend these Rules at any time to address matters not covered herein.</li> </ol>
Exhibition Period, including Occupational Safety, Protests, or Petitions	<ol style="list-style-type: none"> <li>1. Visitors shall comply with the Organizer's crowd control measures. In the event of any of the following circumstances, and where the visitor fails to rectify such conduct after being advised by the Organizer, the Organizer may deny entry, require the visitor to leave within a specified period or immediately, and prohibit re-entry into the venue. All fees paid shall be forfeited without refund, and visitors shall comply unconditionally. The Organizer shall not be liable for any damages suffered by the visitor as a result thereof and reserves the right to pursue legal action for any damages or losses caused by the visitor.               <ol style="list-style-type: none"> <li>(1) Acts in violation of public order or good morals, or acts that adversely affect the image, hygiene, or personal safety at the venue, or otherwise disrupt the exhibition.</li> </ol> </li> </ol>

	<p>A. Producing noise exceeding 85 decibels during the exhibition.</p> <p>B. Harassing, using offensive language, shouting, insulting, threatening, coercing, or harming exhibition staff, exhibitors, visitors, or other personnel.</p> <p>C. Using inappropriate mobility devices, such as hoverboards or skateboards, within the venue or in areas not authorized by the Organizer.</p> <p>D. Being intoxicated or engaging in disorderly conduct within the venue.</p> <p>E. Carrying prohibited, explosive, flammable, or otherwise dangerous items that may cause personal or property damage or disrupt venue order or safety.</p> <p>F. Wearing foul-smelling clothing, slippers, or bringing unclean items that negatively affect the image of the venue.</p> <p>G. Carrying loudspeakers or similar noise-producing devices that disturb venue tranquility.</p> <p>H. Engaging in solicitation or sales activities. Upon verification of any report by staff, exhibitors, or visitors, the Organizer may require immediate or time-limited departure.</p> <p>I. Any other conduct affecting venue order, exhibition operations, or the safety of persons or property.</p> <p>(2) Conducting protests, petitions, or similar activities within or outside the venue (including forums and related event locations) that disrupt order or the visitor experience.</p> <p>(3) Refusing to follow the Organizer's prescribed entry or exit procedures when entering or leaving the venue.</p> <p>(4) Using another person's identification or forged/altered identification documents to enter the venue.</p>

	<p>(5) Using drones for aerial photography within the venue without the Organizer's authorization.</p> <p>2. To maintain venue order and safety, visitors under 12 years of age are prohibited from entry during the exhibition period from Mar. 25 to 26, 2026.</p> <p>3. Visitors shall complete pre-registration or onsite registration as announced by the Organizer and, during the exhibition, present valid admission credentials (e.g., QR code, visitor badge, or ticket) upon entry. A "one person, one pass" policy is strictly enforced. Admission credentials may not be transferred, loaned, misappropriated, or reused. Any violation, once verified, will result in confiscation of the credential, immediate removal from the venue, prohibition of re-entry, and forfeiture of all fees paid. The Organizer shall not be liable for any resulting damages and reserves the right to pursue legal action against violators.</p> <p>4. Where exhibits involve machinery, food processing, packaging, biotechnology, pharmaceutical, or catering equipment, visitors shall follow onsite staff instructions and shall not approach, touch, or operate such equipment. Given crowding, visitors shall remain attentive to their surroundings to avoid collisions or accidents. The Organizer shall bear no liability for personal injury or property damage resulting from non-compliance with the foregoing.</p>
Assumption of Risk Statement	<p>1. Visitor Guidelines :</p> <p>(1) Visitors shall be solely responsible for the safekeeping of their personal belongings during the exhibition to avoid loss, theft, or damage. The Organizer shall bear no responsibility for custody or compensation in the event of loss, damage, theft, or robbery of personal property within or outside the exhibition premises.</p>

	<p>(2) Visitors shall exercise due care with respect to their movement, booth installations, public facilities, and crowd safety, and shall follow the guidance and safety instructions of onsite personnel. The Organizer shall not be liable for any injury, accident, or discomfort arising from personal negligence, the acts of third parties, or force majeure events (including but not limited to earthquakes, typhoons, or unforeseen incidents), and visitors shall assume all related risks.</p> <p>(3) Visitors are advised to obtain travel accident insurance or personal injury insurance at their own discretion for enhanced personal protection.</p> <p>2. Disclaimer of Liability :</p> <p>(1) Visitors expressly acknowledge and voluntarily participate in the exhibition (including peripheral activities) with full understanding and acceptance of all potential risks, whether enumerated herein or not.</p> <p>(2) The Organizer shall not bear any legal liability for accidents, injuries, death, or property loss incurred by visitors during the exhibition (including peripheral activities) resulting from personal reasons, undisclosed health conditions, failure to follow instructions, or other related factors. Visitors, their family members, executors, or related parties shall have no right of action against the Organizer or any related entities or personnel.</p> <p>(3) Visitors agree that the Organizer shall bear no responsibility for any accident, injury, death, or property loss that may occur during travel to or from the exhibition venue (including peripheral activities).</p> <p>3. Visitor Declarations :</p>

	<p>(1) Visitors warrant that they are in good health, have no conditions rendering them unfit to participate in the exhibition or related activities, and have understood the nature and risks of the exhibition and activities.</p> <p>(2) Visitors agree to comply with all rules of the Organizer and follow the instructions of onsite personnel.</p> <p>(3) Visitors agree to promptly notify onsite personnel in the event of any discomfort during the activities.</p> <p>(4) Visitors agree that the Organizer may take photographs, make video or audio recordings, and live-stream at the venue and related activities, and hereby authorize the Organizer to collect, process, and use such materials for exhibition promotional purposes without further notice or compensation.</p> <p>(5) Visitors warrant that they will provide valid identification and information for identity verification by the Organizer, confirm the foregoing statements, and assume corresponding legal responsibility.</p>

	<p>(6) Visitors acknowledge and understand that, for purposes of promoting, contacting, statistical analysis, improvement, and optimization of the exhibition, the Organizer may collect, process, and use personal data provided by visitors through various means (including but not limited to online registration, onsite registration, and participation in interactive activities). Visitors agree that, for the foregoing purposes, the Organizer may collect, process, and use their personal data through various forms (including but not limited to photography, video or audio recording, and live-streaming), and authorize the Organizer to use the collected personal data and images for exhibition publicity for an indefinite period without further notice or remuneration. Visitors providing personal data may exercise the following rights under the Personal Data Protection Act: (1) access or request review; (2) request copies; (3) request supplementation or correction; (4) request cessation of collection, processing, or use; and (5) request deletion. To exercise any of the foregoing rights, please contact the exhibition organizer.</p> <p>(7) Entry into the venue signifies that you have carefully read and agree to the foregoing statements. If you do not agree, you will be unable to participate in the exhibition.</p>
