

ORDINANCE NO. 159

**AN ORDINANCE TO AMEND ORDINANCE NO. 07-149
AND CHAPTER 1 OF TITLE 8 OF THE MUNICIPAL CODE
OF THE TOWN OF UNICOI, TENNESSEE**

WHEREAS, request has been made by the holder of a permit to sell beer for off-premises consumption within the Town of Unicoi for amendment of the ordinance to allow continuation of beer sales to motor vehicles in a convenience market conducting such sales prior to the enactment of the beer ordinance; and

WHEREAS, the Town of Unicoi acting through its Board of Mayor and aldermen in the exercise of the authority to regulate such business has determined it to be reasonable and appropriate to amend the ordinance as set out below; now therefore

BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF UNICOI, TENNESSEE, AS FOLLOWS:

SECTION 1. THAT TITLE 8, CHAPTER 1, SECTION 8-111 is hereby amended to delete the last sentence of said section and the replace said sentence with the following:

This provision shall not apply to holders of off-premise permits lawfully selling and dispensing beer to persons in automobiles or other vehicles through a drive-up window as of January 1, 2007, and/or subsequent holders of an off-premise permit to sell beer for off premise consumption at a location where beer was lawfully sold and dispensed to persons in automobiles for other vehicles through a drive-up window as of January 1, 2007.


SECTION 2. THIS ORDINANCE shall take effect immediately upon second reading and approval thereof, the public welfare requiring same.
