

**ORDINANCE # 05-137**

**AN ORDINANCE OF THE TOWN OF UNICOI, TENNESSEE  
LOWERING THE SPEED LIMIT ON HONEYCUTT ROAD**

**WHEREAS**, the Board of Mayor and Aldermen of the Town of Unicoi are interested in establishing safe speed limits for vehicles traveling in the Town, and

**WHEREAS**, Title 15, Chapter I of the Municipal Code of the Town of Unicoi, states that a speed limit of thirty-five (35) miles per hour will apply in the Town unless otherwise designated, and

**WHEREAS**, Honeycutt Road is unsafe even when vehicles travel at thirty-five (35) miles per hour;

**NOW THEREFORE BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF UNICOI, TENNESSEE AS FOLLOWS:**

Section 1. There shall be established a maximum speed limit of twenty (20) miles per hour on Honeycutt Road.

Section 2. A penalty of up to \$50 shall be imposed for each violation of this ordinance.

Section 3. This ordinance shall take effect from and after its final passage, the public welfare requiring it.


