



ORDINANCE # 2012 - 218

AN ORDINANCE OF THE TOWN OF UNICOI, TENNESSEE TO AMEND THE SCHEDULE OF MUNICIPAL COURT COSTS

WHEREAS, the Board of Mayor and Aldermen desire to amend the schedule of Municipal Court Costs; and,

WHEREAS, the Tennessee General Assembly has amended the laws pertaining to the Municipal Court Costs for the collection of court operational costs; and,

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF UNICOI, TENNESSEE as follows: The schedule of Town of Unicoi Municipal Court Costs is hereby amended to add an additional \$25.00 of court costs payable on each unpaid bill of court costs that remains unpaid 10 days following the court date as shown on the citation or 10 days following the date ordered for payment by the Municipal Court Judge, whichever is later.

- Section 3. The penalty for each violation of this ordinance shall be punishable as a Class C Misdemeanor, with a fine of up to \$50.00 plus Town of Unicoi Municipal Court Costs.
- Section 4. Posting of the fifteen (15) miles per hour speed limit shall be the responsibility of the contractor, utility company or other agency undertaking such construction, repair or maintenance.
- Section 5. Any provision of TDOT regulations concerning construction zone regulation, which is more selective than that set-out herein shall govern.
- Section 6. This ordinance shall take effect from and after its final passage, the public welfare requiring it.




