# **Electing an Essex Police & Crime Commissioner**

## **Your Vote Matters**

Are you aware that <u>you</u> have a vote in the election of the Essex PCC. Elections of **Police and Crime Commissioners (PCCs) in England and Wales** are direct elections in each police area of England and Wales scheduled to take place on <u>Thursday 15 November 2012</u>, having been put back from the originally planned date of May 2012 in order to secure the passage of the Police Reform and Social Responsibility Act 2011 through the House of Lords first. PCC's will replace the Police Authority currently now made up of local councillors and magistrates The Government considers the elected Commissioners to have a stronger mandate than the "unelected and invisible police authorities that they will replace".

The core functions of Police and Crime Commissioners will be to secure the maintenance of an efficient and effective police force within their area, and to hold the Chief Constable to account for the delivery of the police and crime plan. Police and Crime Commissioners will be charged with holding the police fund (from which all policing of the area is financed) and raising the local policing precept from council tax. Police and Crime Commissioners will also be responsible for the appointment, suspension and dismissal of the Chief Constable and the Police and Crime Plans. What they will **not do** is run the police, that is the job of the Chief Constable. Shortly after their election to office, a Police and Crime Commissioner must produce a Police and Crime Plan. That plan must include their objectives for policing, what resources will be provided to the Chief Constable and how performance will be measured. Both the Police and Crime Commissioner and the Chief Constable must have regard to the Police and Crime Plan in the exercise of their duties. A Commissioner will also be required to produce an annual report to the public on progress in policing.

All registered electors (British, Irish, Commonwealth and European Union citizens) living in England and Wales (except London) who will be aged 18 or over on Thursday 15 November 2012 are entitled to vote in the PCC elections. As with local and national elections you will receive a polling card which will tell you which polling station you must use. If you wish to have a postal vote or by proxy and aren't currently registered for this option then contact Southend Borough Council electoral registration team.

**Its important so use your vote** - the new PCC will be setting the priorities for policing in Essex. At the time of compiling this article six persons are listed as candidates:

Its good to be able to report that progress has been made on addressing the problem of cycling on pavements and in particular in and around Southend High Street. Our OPA Chairman, Derek Iles recently met with representatives of Southend Council and the Police regarding this issue that the OPA and others have been highlighting and for which we had been gathering signatures to petition for action to be taken. The Council

# and Police at that meeting confirmed that from mid June between 9.00a.m and 6.00p.m. officers would undertake an operation in the High Street and would issue fixed penalty notices to cyclists where appropriate. The Evening Echo of 26th July featured an article entitled 'Cycling Fines Work' in which PC Martin Knights says we have so far issued 50 fixed penalty notices to cyclists (fines totally £1500) and since doing this there has been a reduction in the number of cyclists using the High Street, and obviously cyclists are more wary now because the police are addressing the issue. PC Knights said the police are taking a common sense approach to issuing the £30 tickets and if a person complies with the police request to get off the bike and doesn't re-offend then they are unlikely to be issued with the fixed penalty notice. Two people had appealed against the tickets but both had been unsuccessful and the fines were payable. The OPA welcomes the initiative but will continue to monitor the situation and we

The OPA welcomes the initiative but will continue to monitor the situation and we have written to the police asking for a regular update on statistics. Our committee members are keeping a note of any 'dangerous' cycling High Street incidents they observe and we will of course continue with our campaign; so please keep on with the signature collection as its important that the current initiative doesn't lapse.

# **SOCIAL CARE REFORM - ITS A LONG TIME COMING!**

We have all been eagerly awaiting the government making real, meaningful commitment and progress and the Dilnot report gave us all some hope. However apart from the recent announcement where the government accepts that there should be a cap on the maximum an individual should pay for care with a figure of £35000 having been reported in the press, there has been very little to report. Government acknowledges that as yet they have not identified any funding stream to meet the cost of this and its looking very much like it will be late next year before they make up their minds. So for now we still have the situation where there are people who are forced to sell their houses to fund continuing care .

Julia Unwin, Chief Executive of the Joseph Rowntree Foundation commented on July 2012 :

While we welcome the publication of the long-awaited Social Care White Paper, we are deeply frustrated that more progress has not been made, and that the decision on how to pay for long-term care has been postponed yet again.

"The Secretary of State says this is a watershed moment. It is not. Extending current practice on deferred payments is entirely sensible, but it is also a sticking plaster. Andrew Dilnot's Commission gave us all hope for a new fair settlement and achieved wide-spread support – it is hugely disappointing his recommendations are not being acted upon now.

"Successive governments have failed to act. Without a sense of urgency more of us face insecurity and uncertainty as we age. The failure to address social care properly will only mean more pressure on the NHS thereby destroying all hopes of a sustainable and functioning health system in the future."

Our friends at Southend & District pensioners campaign article also reported : The storm clouds Are gathering—when your hear phrases like "pensioners never had it so good", then it is time to keep your eyes and ears open. NPC and others report that the Institute for Fiscal Studies (IFS) claim the tax and benefit system for older people should be reformed to pay for the future cost of social care. Dot Gibson is quoted as saying, "The government is spectacularly slow in getting to grips with the issue of care funding, we've had about 20 reports in the last 14 years that have all showed currently the system is in crisis and needs urgent attention". The IFS's thoughts do perhaps give an idea where the governments thinking is going and it's not rocket science to work it out. The government and IFS highlights that tax and benefits such as free prescriptions., free bus passes, free TV licences, winter fuel allowance, priority seat on trains as well as discounted fares should be reformed to pay for future social care costs. So this would indicate that the IFS wants these means tested to the extent that only those on pension credit would get them. Ipso facto pensioners will be paying for the care of other pensioners. David Cameron insists the benefits will not be touched during this parliament but lain Duncan Smith last month suggested the commitment would be reassessed in the run up to the next election! Both these reports give us much to think about and clearly a subject of great concern to so many of us. The OPA along with others will continue to lobby at all levels for prompter action but we need you all to maintain the pressure on your local and central government elected members for a fair and equitable system for Care Home and Social Care at Home to be at the forefront of their decision making.

## GREEN MAN THREAT!

No, not an alien from outer space but much nearer to home.

A Daily Telegraph article *"Green Man is too quick for pensioners to cross safely"* tells us that four in five pensioners cannot cross quickly enough to be safe. When the green man starts flashing it will be five seconds until the traffic gets the green light. University College London used 20ft as their test crossing width and timed 3000 over 65's across this distance. They found that the five seconds given to get from one side the other wasn't enough for 76% of men and 85% of women who participated in the test. After the 5 second time allowed the average man still had 5ft of the roadway still to cross and women 7ft.



**The Lesson?** If your walking is restricted or slower than most never set off if the green man has already started flashing (don't take that the wrong way!) but wait for a 'fresh green man' and begin as soon as the signal is illuminated when there will be a full five seconds in which to cross the road.

**The Conclusion**? Do the young determine such things like this without thought for the less able because its OK for them?

## KEEP SAFE - BE SECURITY AWARE!

*Michael Armstrong - Crime Reduction & Architectural Liaison Officer Southend Police District* offers us some advise about home security: Burglary is a horrible crime. There are **FREE** or very cheap measures you can take to radically reduce the risk of it happening to you. All our homes are different but some general rules apply:

<u>Prevent Access to the rear of your home</u>: Fit a Deadlock or Padlock to side gates, add a security light at the rear of your home. Add a trellis topping to easily climbed fences and gates to prevent offenders from just being able to hop over.

**DoorSecurity**: Most common are <u>Wooden Doors</u>, usually fitted with a rim lock, and perhaps a mortice lock. If you only have a rim lock it should be a deadlocking model and be **deadlocked at all times**. If you also have a mortice lock fitted to the door use it **all the time**.(Remember if others hold keys to your home make sure they have **both** the deadlock and mortice key)

**PVC-U** doors are normally fitted with a multipoint locking system operated by a Europrofile cylinder. This type of door is only <u>correctly</u> locked if, having closed it, you push the handle up, activating the bolts, and then **turn the key in the cylinder and remove it**. If you only push the handle up it is a matter of seconds for a burglar to unlock your door, from outside, without making noise or causing much damage.

<u>Windows</u>: should be closed and locked every time the room is left empty. It is easy within seconds to lean in through and fully open a window. Little windows left open allow thieves to open the adjacent bigger window!

Essex is a very safe county, and following the above guidance reduces the risk of being a victim ever further. Free, impartial advice is available from your local PCSO or Crime Reduction Officer

## Carers Allowance — Don't Miss Out !

The latest email update from Age UK's is a reminder about claiming Carers Allowance and has some good information on qualifying for this allowance explained simply and briefly. It also gave links to factsheets with lots more details So if you look after your partner, or a relative or friend who needs help because they are ill or disabled, then <u>you are a</u> <u>carer</u> and if you are not currently claiming the allowance you may be may be eligible and able to claim. The basic condi-

tions you must meet to qualify are:

- ? Spend at least 35 hours a week in caring activity.
- ? You don't have to live with the person.
- ? Care for someone who receives at least middle rate care component of Disability Living allowance or any rate of Attendance Allowance.
- ? Not earn more than £100 per week after deductions
- ? Not be in full time education

The last may not be relevant and the earnings limit may be a little misleading but help is at hand at the Benefit Enquiry line on 0800 882200 alternatively the DWP website <a href="http://www.dwp.gov.uk/carersallowance">www.dwp.gov.uk/carersallowance</a> has all the information you will need.
