INFORMATION FOR JUNIOR ADVISORS

Junior Advisors serve a two year term on the Board of Directors for the Shiawassee County Agricultural Society. Upon receipt of an application an interview will be scheduled for each applicant by the Junior Advisor Committee. The final selection of the Junior Advisors will be made by the Fair Board of Directors.

The Junior Advisor program was initiated to get the views and new ideas of the young people involved with the fair. One of the ways for the fair to grow is with these new ideas and the input from the Junior Advisors to benefit the youth of the county. We would hope that the Junior Advisors would be able to convey to the fair board the feelings of the youth and any views they might have. Junior Advisors would benefit from their position by finding out the workings of the fair and what an involved process it is to have an annual fair.

Some duties and responsibilities of a Junior Advisor might be:

1. Attend monthly fair board meetings (4th Monday of each month at 7:00 pm) and any special meetings.
2. Attend annual Shiawassee County Agricultural Society dinner/meeting usually held the Second Saturday of December.
3. Serve on Fair Board Committee(s).
4. Required to donate time in the weeks before fair in preparation for the fair.
5. Required to donate time during the fair to assist wherever needed.
6. Assist Fair Board Directors at any time needed.

We know that this can tend to be a time consuming position so we ask that you take that into consideration when making your decision to apply.

QUALIFICATIONS:

1. Applicants must have previously exhibited in the Shiawassee County Fair
2. Applicants must have reached their 16th birthday, but not their 21st birthday, or be a high school junior.
3. Applicants must never have been married, and must have no children and must remain so during their two year term, if chosen.

POLICIES:

1. Junior Advisors will forego all alcohol, tobacco and illegal substances at all times from the day they are selected. The Shiawassee County Agricultural Society maintains a zero-tolerance policy on the use of these substances and not adhering to this policy will result in removal from the Junior Advisor Position.
2. Junior Advisors will attend all meetings; activities and events as required, if not able to attend notification shall be given to the chairperson of the Junior Advisor Committee. (Vicki Oliver)
3. Junior Advisors will avoid places or activities that in any way would raise questions as to one's moral character or conduct.
4. Junior Advisors will use wholesome and appropriate language at all times when speaking in public in informational conversations.
5. Junior Advisors are representatives of the Shiawassee County Agricultural Society and will not participate in inappropriate postings and/or inappropriate pictures on social media outlets.
