## SANCTIONED BY THE AGILITY ASSOCIATION OF CANADA NOTICE TO COMPETITORS



EXHIBITORS, THROUGH SUBMISSION OF ENTRY, ACKNOWLEDGE THAT THEY ARE KNOWLEDGEABLE OF CURRENT AAC RULES AND REGULATIONS INCLUDING, BUT NOT LIMITED TO, THE FOLLOWING:

This event will be held in accordance with the current Rules and Regulations of the Agility Association of Canada (AAC) and is open to all dogs being at least 18 months of age, pure breed or mixed breed, except bitches in season, aggressive dogs, or dogs suffering from any deformity or illness which may affect the dog's physical or mental performance.

As of January 1, 2001, all dogs must have an AAC number before their entries will be accepted in an AAC sanctioned trial, even if only to compete FEO.

Obstacles shall be chosen from those described in the current edition of the Rules and Regulations of the AAC and shall conform to AAC specifications.

No leads, collars, food, toys or any other aids or devices shall be permitted on the course at any time. The only exception to this rule is leading your dog on leash to the start line and taking your dog from the ring on leash when finished. Certain toys MAY be allowed on course for FEO runs at the discretion of the HOST CLUB. If allowed, please be considerate of the dogs before you and after you, as a toy may distract the dog on course and/or may over excite the dog following you in line.

Please take responsibility for your dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or engage in unsafe or disruptive behavior may be asked to leave the trial grounds and no refund of fees shall be given.

All dogs must be penned, crated or attended on leash when not in the ring. All dogs must be under control when exiting the ring. Any dog engaging in aggressive or out of control behavior may upon exit of the ring be disqualified and/or required to leave the trial grounds and no refund of fees shall be given.

Anyone disrupting the trial due to poor sportsmanship or abusive behavior will be dismissed from the trial and no fees will be refunded. Remember that this sport should be fun for the dogs, competitors, spectators, judges and volunteers.

#### **LIMITED ENTRIES RULES**

- Northside Agility reserves the right to refuse any entry.
- Anyone not in good standing with AAC or Northside Agility will not be allowed entry.
- Online entries with ETF (preferred) or mailed in entries with cheque
- Entries must be postmarked between January 2, 2019 and up to and including January 25, 2019.

Entry acceptance is <u>not</u> solely based on postmark date or entry date. Considerations for entry acceptance may include (but are not limited to): proportion of entries, and volunteer commitment.

Refunds will not be given for cancellations after the closing date *except* for bitches in season or injury to a dog, or handler, which physically prevents them from competing. Refunds requested for any other reason will be handled on a case-by-case basis and will be at the discretion of the Northside Trial Committee. (A \$10 administration fee will be applied to any refund request received after the closing date.)

There will be a \$25 charge on NSF cheques.

#### **CLASS CHANGES**

Class changes and/or withdrawals made after the closing date may not appear in the gate lists. Please make every effort to get your changes to the trial secretary ASAP.

In consideration of the acceptance of this entry by AAC and Northside Agility (the "Organizing Club") and the opportunity to have the Dog participate, compete in and/or be judged at this event or trial (the "**Event**"), I, the undersigned, agree as follows:

- 1. I certify that I am the actual owner of the Dog, or that I am the duly authorized agent of the actual owner of the Dog and that the Dog is not a hazard to persons, property or other dogs.
- 2. I agree that AAC or the Organizing Club for the Event may refuse my entry for any reason that it deems to be suffficient.
- 3. I understand and acknowledge that participation in the Event carries certain risks, including, but not limited to injuries (including serious injuries and death) to myself, the Dog, another dog under my control or persons attending as my guests (my "Related Parties"), damage to property and other losses. I waive any and all claims that I have or may have in the future against, and release from all liability and agree not to sue AAC, the Organizing Club or any of the directors, executives, committees, representatives, employees, volunteers or agents of either AAC or the Organizing Club (the "Personnel") for any injury, death, property damage or other loss that I or my Related Parties sustain due to any cause whatsoever, including negligence, breach of contract, breach of duty, statutory or otherwise, or mistakes or errors of judgment of any kind.
- 4. I assume full responsibility for the conduct of myself and my Related Parties during the entirety of the Event. I agree to indemnify and save harmless AAC, the Organizing Club and the Personnel from and against any and all claims that may be made against them or costs, fees, expenses or liability (including, without limitation, lawyers' fees on a solicitor and own client basis) incurred by AAC, the Organizing Club or the Personnel that may arise due to:
  - (a) any act or omission of myself, my Related Parties or any party for whom I am liable at law; or
  - (b) aggressive behavior by the Dog or any other dog under my control.
- 5. I have read, and do understand the rules of competition and the additional rules (if any) appearing in the trial schedule for the Event, as well as the policies of AAC pertaining to discipline (collectively, the "Rules"). I agree to abide by the Rules and to conduct myself and the Dog in accordance with the Rules. I understand that myself and/or the Dog may be subject to disciplinary procedures or sanctions for breach of the Rules and agree to respect and be bound by any disciplinary decision made by AAC.
- 6. I understand that AAC and/or the Organizing Club may, in the course of administering the Event or conducting its activities generally, collect, use or disclose my personal information and that any personal information collected, used or disclosed by AAC and/or the Organizing Club will be treated in accordance with AAC policy and applicable privacy and personal information laws. I hereby consent to the collection, use and disclosure by AAC and/or the Organizing Club of my personal information.
