## Please read and sign

In consideration of the acceptance of my entry, I, for myself, my heirs, executors and administrators, do hereby release and forever discharge Dunnville Grand Tour, and its officials, volunteers, sponsors and any other parties connected with the Dunnville Grand Tour event, from all claims for damages, death, personal injury or loss of property I may have as a result of my participation in the Dunnville Grand Tour recreational bicycle ride being held on Aug 18, 19 and 20, 2017.

I am aware that the ride may contain some risks, including the risk of falling, collision with other bicycles, motor vehicles or stationary objects, the effects of weather conditions, and the conditions of the road. I voluntarily assume all risks of loss, damage or injury that may be sustained while participating in the Dunnville Grand Tour. I hereby consent to and permit emergency treatment in the event of injury or illness. I attest that I am physically capable and sufficiently trained to ride in the Dunnville Grand Tour. I attest that the equipment I will use is in good mechanical condition.

I UNDERSTAND THAT BICYCLE HELMETS CAN PREVENT SERIOUS INJURY AND I AGREE TO WEAR ONE WHILE PARTICIPATING IN THIS EVENT and that at no time will I wear anything such as a baseball cap or headphones that may inhibit the correct use of a properly worn helmet.

I agree to obey all Ontario Highway Traffic Act laws. I agree not to sue and I further agree to indemnify and save harmless Dunnville Grand Tour, and its officials, volunteers, sponsors and any other parties connected with Dunnville Grand Tour event, from all expenses, fees, liability or damage award or cost of any type whatsoever arising from my participation in this event. I have read and understand everything written above and I voluntarily sign this agreement.
