**YOU MAY PAY YOUR TRAFFIC CITATION INSTEAD OF APPEARING IN COURT**

By signing the back of the Citation you waive your right to appear in Court. Remit the proper amount due with your signed copy of the Citation before your Court date. Remittance may be made by mail. See the amount entered for Bond amount.

**IF YOU WISH TO APPEAR OR ARE REQUIRED TO APPEAR**

You must appear on your Court date (written on the bottom of your ticket) at 7:00 P.M. You may enter a plea of Guilty, No Contest, or Not Guilty. If you are found Guilty, payment of fine and costs is required at that time. A plea of Not Guilty will continue your case to a later date. You will receive notice of that date at your initial appearance. You may represent yourself or you may obtain private counsel.

**PENALTY**

**SPEED:** If within one year of the offence, the offender previously has been convicted of or plead guilty to two violations of any provision of this section or any provision of a municipal ordinance that is substantially similar to any provision of this section this charge is a misdemeanor of the fourth degree

If within one year of the offence, the offender previously has been convicted of or plead guilty to three violations of any provision of this section or any provision of a municipal ordinance that is substantially similar to any provision of this section this charge is a misdemeanor of the third degree

**OTHER Violation:** If within one year of the offence, the offender previously has been convicted of or plead guilty to one predicate motor vehicle or traffic offence this charge is a misdemeanor of the fourth degree.

If within one year of the offence, the offender previously has been convicted of or plead guilty to two predicate motor vehicle or traffic offence this charge is a misdemeanor of the third degree.
