A Tier 1 sex offender is the lowest level, with the offenses ranging from voyeurism, sexual imposition, pandering obscenity, menacing by stalking with sexual motivation and importuning. Tier 1 offenders must register their address every year for 15 years.

Tier 2 sex offenders must register their address every 180 days (6 months) for 25 years. Offenses in this tier include pornography, child endangering, compelling prostitution and gross sexual imposition victim under 13, among others.

The most severe sex offenders are given a Tier III designation. Lifetime address registration, and must verify the address every 90 days (3 months). This tier includes sex offenses that range from rape, sexual battery and murder with sexual motivation, to kidnapping of a minor to engage in sexual activity, to unlawful death or termination of pregnancy as a result of committing a felony with sexual motivation.
