MOORING.

YOU HAVE BEEN ALLOCATED A MOORING WITHIN THE CLUBS ALLOCATED MOORING AREA BY THE MOORING OFFICER. YOUR ATTENTION IS DRAWN TO THE CLUBS RULES WHICH GOVERN THESE MOORINGS.

TO CONTINUE TO HAVE THE PRIVILEGE OF THE ALLOCATED MOORING YOU MUST BE A FULL MEMBER AND;

YOUR MEMBERSHIP FEE IS TO BE PAID BY 1ST JANUARY EACH YEAR  
YOUR MOORING FEE TO BE PAID ON 1ST OCTOBER EACH YEAR

COMPOUND SPACE

IF YOU HAVE BEEN GRANTED A COMPOUND SPACE, YOUR ATTENTION IS ALSO DRAWN TO THE RULES. YOUR COMPOUND SPACE IS ALLOCATED BY THE COMPOUND OFFICER.

A COMPOUND FEE IS PAYABLE WEEKLY/MONTHLY IN ADVANCE, CURRENTLY £15 AND £35 THEN £50 RISING TO £75  
TRAILORED BOATS CURRENTLY £400.00 PER ANNUM

YOU MUST KEEP YOUR BOAT IN A REASONABLE STATE OF REPAIR. IF YOU DO NOT WORK ON YOUR BOAT, THE COMMITTEE, CAN, AT THEIR DISCRETION, INCREASE THE COMPOUND FEE UNTIL YOUR BOAT IS OF A SATISFACTORY STANDARD OF REPAIR AS DECIDED BY THE COMMITTEE.

THE COMMITTEE RESERVES THE RIGHT TO MOVE YOUR BOAT BACK TO ITS MOORING, OR BE REMOVED COMPLETELY FROM THE CLUB PROPERTY IF YOUR BOAT REMAINS IN AN UNACCEPTABLE STATE OF REPAIR.

IN THE EVENT THAT ARREARS ARE OWED TO THE CLUB, THE COMMITTEE HAS A LIEN OVER YOUR BOAT UNTIL THE ARREARS HAVE BEEN RECEIVED IN FULL.  
THE COMMITTEE RESERVES THE RIGHT TO SERVE A 'NOTICE OF INTENTION TO SELL' IF ANY LIEN IS NOT SATISFIED WITHIN A REASONABLE TIME. YOU ARE WARNED THAT YOUR BOAT AND ITS CONTENTS WILL BE SOLD AND THE PROCEEDS WILL BE USED TO PAY THE ARREARS OWED TO THE CLUB PLUS ANY EXPENSES IN RELATION THERETO.

GENERAL

THE COMMITTEE RESERVES THE RIGHT TO INCREASE FEES AS AND WHEN NECESSARY.  
THE COMMITTEE RESERVES THE RIGHT TO AMEND OR ALTER THE CONDITIONS AND RULES OF THE CLUB AT ANY TIME.

THE COMMITTEE RESERVES THE RIGHT TO CANCEL YOUR MEMBERSHIP AND/OR REMOVE YOUR BOAT FROM THE CLUB PREMISES, IF YOU ARE IN BREACH OF ANY OF THE ABOVE TERMS AND CONDITIONS.
