I acknowledge that my or my child's and/or guardian's participation in activities sponsored by The Beach Blast is strictly voluntary. I hereby certify that I am over the age of 18 years old; I have carefully read the foregoing covenant not to sue and acknowledge that I understand and agree with all above terms and conditions stated in this covenant. Rules & Policies

Waivers must be signed prior to accessing inflatables. Wristbands <u>MUST</u> be worn to access inflatables.

No food, drinks & gum allowed in/on inflatables.

No smoking inside or directly outside entries/exits to our facilities.

No fighting, foul language, or threatening behavior will be permitted. All violators will be removed without a refund.

Please remove shoes, glasses, and all objects from pockets before bouncing. No sharp objects or jewelry in bounce areas!

No flipping, acrobatics, or gymnastics. No wrestling or rough play on or in units. You and your child will be removed permanently if your behavior and/or actions have been deemed unruly or unsafe.

Attendants are authorized to manage the flow of riders. Adults & older kids are generally separated from smaller kids for safety reasons. Follow attendant's instructions at all times

All bouncing guests must be under 250 lbs. Adult bouncing may be restricted during peak hours and on certain units. Kids will always have the priority over adults. No big kids in designated toddler areas.

No Lifeguards on duty! Swim at your own risk.

No diving anywhere.

You must be 16 years of age, or older, to go to beach area without an adult.

We ask that ALL swimmers bring and wear a life jacket.

No alcoholic beverages are allowed onto the beach.

All trash must be discarded in the proper places before you leave.

No refunds due to weather or accidents or incidents out of The Beach Blast's control.

Do not throw rocks or sand! All violators will be removed without a refund.

Pets are not allowed on premises except for permitted service dogs. Pets are not to be left in vehicles.

No nudity, thongs or excessively exposing swimwear or clothing with offensive language will be allowed.

Pop-Up canopies are available for rent and must be provided by The Beach Blast.

No weapons are allowed on the beach.

You are responsible for the safety and care of all your belongings at all times.

Please be respectful and obey The Beach Blast staff. Disrespectful behavior towards staff will not be tolerated and you will be removed from the facility without refund.
