## STUD CONTRACT

### **STUD DOG OWNER**

The stud dog owner warrants that no other dog but the stud listed above will be introduced or bred to the above listed bitch. Special care and attention will be provided to ensure against any accidental breeding while the bitch is in residence of the Stud Dog Owner. (If the bitch is to take residence with the stud dog owner.)

The stud dog owner shall provide all reasonable care for said bitch while she is in the stud dog owner's charge including feeding, water, exercise, and affection. Every precaution will be taken to ensure against disease, injury, accident, loss, or death of the bitch. If veterinary care is needed at any time while the bitch is in stud dog owner's care, the breeder is expected to reimburse stud dog owner/veterinarian for said costs, PRIOR to said bitch's return to her owner. Stud dog owner is not held responsible for any of the above occurrences, unless said occurrences were to gross negligence on their part.

### **General Care/Conditions**

Breeder shall list any and all special care needs for bitch here, all needs shall be discussed with stud dog owner PRIOR to final agreement:

Any supplements must be placed in a Ziploc bag or individual plastic container for each day/feeding and be properly labeled.

\_\_\_\_\_ (Initial accepting fee for boarding) Delivery to/from stud dog owner is the responsibility of the breeder, unless other arrangements have been made.

IF the bitch remains at the stud dog owner's facilities beyond 7 days, breeder will pay \$15.00 per day boarding fee for every day over the first 7.

### **STUD SERVICE CONTRACT**

The stud dog will attempt to service the bitch at least two times. In the event the bitch cannot be bred naturally, breeder may request that the bitch be artificially inseminated. If such is the case, stud dog owner will have the bitch artificially inseminated by a licensed veterinarian of their choice and breeder will pay the vet clinic for all costs involved with this procedure.

Stud dog owner will provide the breeder with written synopsis of the bitch's behavior during her stay at the stud dog owner's facilities. This will outline eating habits, interaction with people and dogs on the premises and interaction with the stud dog. This will also include the exact dates, times, and length of ties of each breeding that occurs. This may be done via email, facebook, or text.

### **FEE or POL:**

\_\_\_\_\_ (Initial accepting POL for service) The stud fee for this breeding is 1st pick from the resulting litter. Picks shall be made pending any requested color testing and any pre negotiated exclusions. Pick shall be number 1. If 10 or more are born Stud Dog Owner is to get 1<sup>st</sup> and 3<sup>rd</sup> pick of the litter.

\_\_\_\_\_ (Initial accepting stud fee for service) Stud fee is \$2000. Half is to be paid up front, the other half is due at confirmation of pregnancy or when the litter is born. In the event the bitch does not take or has a litter of 3 puppies or less, the Stud Owner will offer a free repeat breeding with said bitch.

### **BREEDER**

- Breeder warrants that the bitch listed and described above is owned/leased by them and that they have every right therefore to perform this breeding. If Breeder leases the bitch, Stud Dog Owner will be supplied with a copy of the lease agreement between Breeder and Owner.

- Bitch has NO known genetic defects and is of sound temperament.
- Bitch is crate and leash trained and knows basic commands.
- Breeder warrants that the bitch listed and described above is current on all vaccinations and is free of all worms, fleas and ticks.
- Breeder may use any photos of the Stud Dog and may reference [www.GulfCoastGreatDanes.com](http://www.GulfCoastGreatDanes.com) in litter advertising. As well Stud Dog Owner may use litter pictures in any advertising. Breeder is to provide litter pictures on a weekly basis to Stud Dog Owner.
- Breeder is responsible for all shipping costs of the bitch to and from the Stud Dog Owner's premises. If shipping is accomplished by Stud Dog Owner driving more than 30 miles from home, Breeder will reimburse Stud Dog Owner for gas and usage of their vehicle at a rate of \$.50/mile. No bitch is to be sent COD or collect to Stud Dog Owner.
- If Breeder is requesting fresh chilled or fresh frozen semen collection from above listed stud dog, Breeder will assume all monetary costs for procedures. This includes but is not limited to, collection of sperm, shipment via the most expedient way and artificial insemination of bitch upon arrival. All the same requirements, health tests, and statements of this contract will still apply to both parties.
- Breeder will notify Stud Dog Owner as soon as referenced bitch comes into heat or earlier, so that arrangements can be made in a timely manner to ship/breed. Breeder warrants that the above listed and described bitch has not been introduced to any other males at any time during this current heat cycle and could not have been bred by any other male prior to delivery to Stud Dog Owner's facilities. Breeder also guarantees this bitch will not be exposed to any other males after this breeding upon her return home. All care will be taken by Breeder to prevent contact until such time as her heat cycle ends. Breeder will supply Stud Dog Owner with enough food supply for the bitch while in the care of Stud Dog Owner. If food cannot be supplied by Breeder, Stud Dog Owner will be notified of brand, etc. and make every effort to accommodate the bitch. Breeder will reimburse Stud Dog Owner for any food and supplements that will be fed to the bitch while in the care of Stud Dog Owner. If the bitch remains at the Stud Dog Owner's facilities beyond 7 days, Breeder will pay a \$15.00 per day boarding fee for every day over the first 7 and cost of extra feed.

Upon validation of this contract Breeder agrees to furnish Stud Dog Owner with the following as it pertains to said bitch:

1. If Breeder leases bitch, lease agreement between bitch owner and Breeder.
2. Copy of ANY/ALL registration papers.
3. At least two color photos
4. The number of the Breeder's Veterinarian
5. Negative Burcellosis from Veterinarian. MUST be dated within 14 days of service. (If live cover is being rendered)
6. Progesterone test results, which needs to be done at day 7-8 of bitch's heat cycle. NOT CELL CYTOLOGY.

Breeder agrees to the following regarding the litter(s) that result(s) from this and/or return breeding:

- Breeder warrants that ABSOLUTELY NO puppies from this breeding will be sold into or by the commercial dog market. This includes but is not limited to Pet Stores, Puppy Mills, and Mall stores. Failure to ensure this on the part of the Breeder could result in suit of damages.
- Breeder warrants that ABSOLUTELY NO puppies from this breeding will be released to or handed into any Shelter, SPCA, Humane Society, or Rescue Organization.
- Breeder will supply Stud Dog Owner with color photographs of all surviving puppies of this litter.
- All puppies will be sold on a return contract with either the Stud Owner or Breeder.

• Per GCD Policy NO puppies sired by GCD \_\_\_\_\_ shall ever be sold on FULL registration unless mutually agreed upon. ALL CO-OWN breeding homes must be mutually agreed upon by both Breeder and Stud owner. THESE TERMS ARE NON NEGOTIABLE. Should this be violated, GCGD reserves the right to refuse registration to entire litter.

\_\_\_\_**Initial**

• Should puppies become infected with giardia and/or parvo or any other malady the Stud Dog Owner reserves the right to request and receive a substitute cash payment in lieu of POL. Breeder must also notify ALL potential buyers of condition of said puppies. \_\_\_\_**Initial**

- If pick puppy becomes sick and dies, stud owner has the right to pick another puppy whether the others are reserved or not. Pick of litter is pick of litter. Unless otherwise agreed upon.
- It is the Bitch Owner's responsibility to notify the stud owner if their pick is sick.
- Bitch shall not be sold or given away until puppies have been weaned.
- Should bitch not willingly stand for service or become vicious towards Stud to a degree that risks damage to the Stud, the owner will be notified to pick up bitch immediately.

**AGREEMENT:**

Both parties agree that all paperwork required in this document will be supplied to the applicable parties. It is also understood and agreed that the Stud Dog Owner has the right to refuse to breed the listed stud if any of the paperwork submitted by Breeder does not meet the requirements of the Owner. This includes (but is not limited to) health certificates, pedigrees, etc. It is also agreed and understood by both parties that any and all money, paper work, pictures or requirements that are not sent in a timely manner or not met, will be considered breach of this contract and thus, Owner has no obligation to sign the applicable litter registration papers until requirements are met by the Breeder, or viceversa. All private communication shall remain private, co-owner and breeder shall have civil discussions at all times. Neither shall disparage the other either privately or in a public forum. This shall be considered a severe breach of contract.

The signatures below constitute agreement of the above listed terms by both the Stud Dog Owner and Breeder. In the event that Owner should breach this contract there will be a 1500.00 fee assessed to them, depending on what was breached. Should there be an actual event where this contract should go to court Owner agrees to pay and/or reimburse ANY and ALL expenses to include but not limited to filing fees, attorney fees, missed wages and traveling fees for GCGD /Brittney Newman, should the Owner be found at fault. GCGD prefers to settle outside of court in a civil manner, however all cases to go to court will be settled within the BREEDERS state of Florida and county of Escambia.
