ROLL CALL

Mayor Harold Hove in the Community Center called the regular meeting of the Stanhope City Council to order at 6:30 P.M. on October 09, 2018. Council Members answering roll call were: **Roger Hayes, Jr., Terry Painton, Steve Earl,** and **Crystal Renze.** Council Member **Nila Zanker** was recorded as absent. Members of the public present: **Gina Myers, David Myers, Vicki Anderson, Polly Hayes,** and **Mike Hanson.** **Clerk Murray** acted in the position of Secretary. Meeting was recorded.

CONSENT AGENDA

FIRE HYDRATES

Gina Myers ask council if all the fire hydrates in town work with all the resent fires activities. Council and Fire Chief answered and explained that they all work, some are slow. Vicki Anderson asked about the one south of their house because when you turn it on it sucks out the pressure form their home. All but 3 do that to some homes. That is not the only one. Iowa Rural Water Association was going to come back and test some more but has not made it back. Only 3 have enough pressure to fill up a truck. When there is a fire the truck come in full. They call for water assistance if they need it from other cities. They have a porta tank they use to keep the trucks full. Sometime they hook up a hose to a hydrate and the porta tank to keep the porta tank full, otherwise they go to one of the 3 hydrates with the trucks to fill. They get flushed twice a year, painted and oiled every two years, or as needed.

Jarold is going to court for the garbage burning and we will wait to see what happens. Terry would like to see if we can remove the burn barrel. Roger would like to know what the penalties are and if we can change them. Roger also would like our local police to come to the next meeting and fill us in and answer any questions the council may have. Terry would also like to see about burning times. Clerk Murray said she didn't know and will have to look it up. If we don't have one Terry wants one. Other Council says that is a gray area and will have to see what else we can do. If need be council says call the lawyer to find out our options.

FIRE DEPARTMENT FLOOR

PARKING

Council would like Mike or Jessica to looking into getting one for the other side of the road by Sparky's, which IDOT regulates and will have to request from them.

BUILDING PERMIT & BUILDING

Motion carried.** Clerk Murray talked to lawyer and he said permit is fine. Lawyer told Clerk to email owner about making the wall that will be the new outer wall reinforced to make it an outer wall. Must have a safety inspection. Clerk also told council that lawyer said to put no signs or other fence up. It is his property. As soon as the city does that, they take liability in it. It is the property owner responsibility and not ours.

COMMUNITY BUILDING AC

Council wants to table until March 2019 since it is so late in the year and this doesn't affect the furnaces.
