ROLL CALL

The regular meeting of the Stanhope City Council was called to order at 6:27 P.M. on May 15, 2019 by **Mayor Harold Hove** in the Community Room located in the Community Center 600 Main Street. Council Members answering roll call were: **Nila Zanker, Roger Hayes, Jr., Crystal Renze, Steven Earl,** and **Terry Painton**. Members of the public present: **Polly Hayes, Office Morton,** and **Jackie Baker**. **Clerk Murray** acted in the position of Secretary. Meeting was recorded.

CONSENT AGENDA
