

**Historic Waverly Neighborhood Association Monthly Meeting
October 3, 2016
Allen University Community Center

The meeting was called to order at 6:10 PM

A devotion was offered by Charlie Collins.

Louis Dessau moved that the agenda that was presented be accepted. It was second by James Baker. The body voted to approve the agenda as presented.

The minutes of the last meeting were emailed to all association members with an email address on file. Louis Dessau moved that the minutes from the September 12, 2016 meeting be accepted as sent. The motion was seconded by George Bradley. The motion passed.

Officer Santos, neighborhood security officer gave his report to members of the association. Of particular note, Officer Santos asked that resident be on the lookout for a white work van with the license plate SC 9854-JW that has been parked in the neighborhood. The treasurer's report was given by Sylvie Dessau. The account balance as of October 3, 2016 is \$634.55. Tina Marshall-Bradley moved to accept the treasure's report as presented. It was seconded by Malcolm Harris. The motion passed.

The report on the storm drains was given by Louis Dessau. He reported that he was not able to contact representatives from the universities regarding student volunteers. Nimai Garrett, Director of Alumni Affairs/Parent Engagement from Allen University indicated that he would assist him with contacting the appropriate representative from Allen University.

Frank Houston gave the president's report. He reported that the HWNA will be submitting a proposal for the 2016 ACTION grant to replace the large signs at Milwood and Hampton, and Harden and Hampton so they match the street sign toppers that were purchased with funds from last year's grant. He also reported on community cleanup activities sponsored by members of Wesley United Methodist Church. He also reported on the guideline to be voted on the Planning Commission on October 10, 2016 at 5:15 PM at City Hall. Following that hearing there will be a meeting of City Council, on November 15, 2016 at 7:00 PM, at City Hall. The final meeting is scheduled for City Council, second reading on December 6, 2016 at 6:00 PM at City Hall. James Baker voted to accept the report, Louis Dessau seconded.

Nimai Garrett provided the body with information about Allen University's homecoming celebration. He invited all residents to attend all events sponsored by the university. Allen University's homecoming celebrations will take place from November 6-13, 2016

Petrina Green, representing Richland School District One (1225 Oak Street), updated the association on property issues near the Richland School District One complex. She also provided some information on

events sponsored by the school district. She indicated that if the HWNA would like to use the parking lot of the complex, that it was available.

Diane Wiley, president of the Belvedere Community Association, shared information on a meeting sponsored by the Central Midland Council of Governments (CMCOG) to be held on Wednesday, October 5, 2016 from 6:00 PM – 8:00 PM at the Richland Library (Main Branch) 1421 Main Street, Columbia, SC. She encouraged members of the HWNA to attend this meeting.

A representative from Richland School District One as well as two student volunteers from Benedict College presented a DVD documenting the lives of Waverly residents from the 1970s. This DVD was developed by the district from a VHS tape presented by James Baker of Oak Street. It was suggested that the contents of the DVD be converted to a YouTube video and posted to the HWNA website.
