WHAT can be Recycled?

Bale Twine

(Polypropylene)
Made into new agricultural recycled twine.



Agricultural Pesticide Containers

Made into plastic products such as plastic lumber, parking curbs, guard rails, etc.



HOW do I prepare the material?

Bale Twine

TO AVOID REFUSAL, please clean off hay, mud and debris. Twine containing no more than a 5 % contamination rate cannot be recycled.

Keep Twine clean and dry by storing immediately after removing from bales in clear, plastic bags. Tie filled bags closed so that contents will not spill out and remain dry. NOTE: NO SISAL TWINE.

We provide clear plastic bags for your twine. Please ask your nearest collection site for bags. No loose Twine will be accepted for recycling.

Agricultural Pesticide Containers.

MUST be triple rinsed or pressure rinsed

ONLY empty containers, caps off and booklets must be removed. Please recycle booklets.

RECYCLE at your nearest collection site.
