

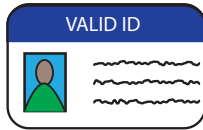
# FREE TAX PREP

Through the **Volunteer Income Tax Assistance (VITA)** program, **United Way of the River Cities' (UWRC) Financial Stability Partnership (FSP)** in collaboration with the IRS and local organizations, coordinates free income tax preparation for low- to middle-income families at a variety of physical locations and online during the filing season.

## WHEN YOU COME TO YOUR TAX APPOINTMENT, YOU MUST BRING:



- Photo Identification** - taxpayer and spouse
- Social Security cards or statements for **EVERYONE** on the tax return**

- All income documents** such as W-2; 1099s from retirement/pension, Social Security, unemployment, interest, dividends; self-employment info, etc.
- Form 1095-A** Health Insurance Marketplace Statement, if you have Marketplace Coverage
- Form WV/SCTC-1**, if you are eligible for the **WV Homestead Credit / Senior Citizen Tax Credit**
- Not sure if it is a tax document? Bring it! We can help.
