5. I understand that abuse or violation of any of these rules may result in the immediate cancellation of my privileges to use the clubhouse and that my Clubhouse Key Card may be de-activated during an investigation or appeal.
6. I agree to pay a deposit of **\$20.00** per Clubhouse Key Card. I understand that this deposit will be refunded if the Clubhouse Card is surrendered, undamaged, to the Treasurer at the above address within 30 days of cancellation of Membership or privileges to use the clubhouse. Failure to apply for refund and to surrender undamaged card within 30 days will result in the \$20.00 deposit being forfeited to **LHTC** and will result in deactivation of Clubhouse Key Card.
7. I agree to pay an annual Clubhouse Key Card user fee, of **\$5.00** per key, upon membership renewal each year. **I agree to immediately report, in writing, to above addresses if any Clubhouse Key Card is lost or stolen.**
8. I understand that all Clubhouse Key Cards are the property of **LHTC** and are to be returned to **LHTC** upon termination of membership as per **item 6** above.
