# Mass Offerings

An individual may ask a priest to offer a Mass for several reasons: for example, in thanksgiving, for the intentions of another person (such as on a birthday, anniversary or for a recovery from illness), or, as is most common, for the repose of the soul of someone who has died. One must never forget the infinite graces that flow from the Sacrifice of the Mass which benefit one's soul.

St. Ambrose preached, "We have loved them during life; let us not abandon them in death, until we have conducted them by our prayers into the house of the Lord." St. John Chrysostom stated, "Let us help and commemorate them. Finally, Pope St. Gregory said, "Let us not hesitate to help those who have died and to offer our prayers for them."

Given this understanding, we can add some specifics. When a priest offers Holy Mass, he has three intentions:

- First, to offer the Mass reverently and validly in accord with the norms of the Church.
- Second, to offer the Mass in union with the whole Church and for the good of the whole Church.
- Third, to offer the Mass for a particular intention, such as the repose of the soul of someone who has died or for who needs divine intervention..

We find not only the origins of this practice dating to the early Church but we also clearly recognize its importance. When we face the death of someone, even a person who is not Catholic, to have a Mass offered for the repose of his soul and to offer our prayers are more beneficial and comforting than any other sympathy card or bouquet of flowers. To have a Mass offered on the occasion of a birthday, anniversary or special need is appropriate, beneficial and appreciated.
