Statement of Faith

We believe in one God who is made up of three co-equal, co-eternal persons, namely, the Father, the Son, and the Holy Spirit.

We believe that God created man in His own image, and has called him to manifest and reflect holiness through obedience to His commandments. Because man has failed in this responsibility, and refused to honor God as God, man has fallen into a state of moral corruption, and has become alienated from his creator.

But God, being rich in mercy, because of His great love, has initiated a plan of redemption and reconciliation for mankind. The pinnacle of which is found in the life, death, and resurrection of Jesus of Nazareth, the incarnation of God. He was conceived by the Holy Spirit, and born of the Virgin Mary, being at the same time fully God and fully man. He lived a sinless life, was crucified, died, and was buried. On the third day after His death, He rose again, and ascended into heaven, and now sits at the right hand of God the Father Almighty, and He will come again to judge the living and the dead.

We believe, Jesus Christ, through His substitutionary, atoning death and bodily resurrection, has provided the basis of our justification, which, by God's grace we receive by faith alone. God initiates this reconciliation through the regeneration of our hearts, which is witnessed by our repentance and confession of faith in the Lord Jesus Christ. Our great hope is the redemption of our bodies through resurrection to eternal life, which will complete our adoptions as sons.

As the supernatural and sovereign Agent in regeneration, the Holy Spirit baptizes all believers into the Body of Christ at the moment of salvation. He dwells in the hearts of every believer, effecting their regeneration, operating in their sanctification, instructing them into all truth, and sealing them until the day of redemption. In addition to this, the supernatural gifts of the Holy Spirit are for the church today, including the gift of speaking in other tongues.

We believe that the Bible, in its entirety, is divine revelation, and we submit to the authority of Holy Scripture, acknowledging it to be inerrantly inspired by God and carrying the full weight of His authority, and therefore it alone is the standard for faith and practice.

Employee Ethics/Conditions of Employment

Each staff member accepts as his/her own the following statements and has a signed copy of these statements in his/her personnel file.

1) I agree that, as part of the qualifications for this position, I am a "born-again" Christian who knows the Lord Jesus Christ as Savior (John 3:3, 1 Peter 1:23). I accept without verbal or mental reservations the school's Statement of Faith (attached), and am committed to upholding it. I also give testimony that serving in Christian education is a spiritual calling and that employment in this Christian school is God's direction for my life for this school year.

2) I agree to manifest by daily example the highest Christian virtue serving as a *Christian role model* (1 Timothy 4:12) both in and out of school to pupils (Luke 6:40), parents, and fellow employees. I agree that instruction is not only through rational explanation of formal subject material, but even more powerfully through word, deed, example, and shared experience. I agree to be a role model in judgment, dignity, respect, and Christian living. I acknowledge that this includes, but is not limited to, the refraining from such activities as the use of illicit drugs, and the use of vulgar and profane language. With regard to tobacco and alcoholic beverages, I agree to refrain from use when in a position to represent the school and to be sensitive in how my use reflects upon the ministry of the school. Faith Community Church is a nonsmoking facility and employees are not permitted to come to work with the smell of smoke or chewing tobacco on their person. No alcoholic beverages are permitted on FCC premises at anytime. (Col. 3:17 KJ, Titus 2:7-8 TLB, 1 Thess. 2:10 TLB, 1 Thess. 5:18, 22-23 KJ, and James 3:17-18). I agree to uphold this Christian example in public and in private, including the world of social media and internet persona(s).

3) I agree to accept the board's interpretation of biblical standards for my sexual behavior. That any sexual misconduct—including, but not limited to—premarital, extramarital, co-habitation, or homosexual activity; sexual harassment; use or viewing of pornographic material or websites; and sexual abuse of children is forbidden and violates the employment requirement of being a *Christian role model*. I agree that such behaviors are grounds for immediate dismissal from my position of ministering to children.

I also agree that the unique roles of the male and female are clearly defined in Scripture, and that Romans 1:24-32 condemns the homosexual lifestyle (Romans 12:1-2; 1 Cor. 6:9-20; Ephesians 4:1-11, 5:3-5; 1 Thessalonians 4:3-8; 1 Timothy 4:12; 2 Timothy 2:19-22; 1 Peter 1:15-16, 2:15-17; 1 John 3:1-3).

4) I agree to faithfully attend and financially support a local church whose fundamental beliefs are in agreement with the Statement of Faith of this school (Hebrews 10:25).

5) I affirm that I have read and will abide by my Job Description, the policies set forth in the Employee Handbook, and the Parent Handbook. I also agree to abide by any additions, changes, or deletions made to school policies at the sole discretion of the administration and Faith Community Church board without prior notice during this agreement year.

6) I agree to provide the Administrator with a transcript of college and graduate studies and any applicable teaching certificate prior to the first day of school or make other acceptable arrangements with the administration. Failure to do so voids this contract.

7) I agree that my assignment to room, grade, subject, and extracurricular duties is to be made at the discretion of the Administrator. I agree to maintain a classroom atmosphere that is conducive to learning. This includes maintaining a professional appearance.

8) I agree to try at all times to understand, appreciate, love, and serve the pupils entrusted to me for instruction, and will to the best of my ability provide for their fullest spiritual, intellectual, physical, and emotional development. I agree to observe appropriate confidentiality in regard to pupil, parent, and school matters.

9) I agree to avoid highly debatable topics as much as possible that tend to divide Christians. I agree that a student is to be referred to his/her local church and parents if a debatable topic arises of a theological nature. The position of the school according to the Statement of Faith is the basis for the teaching in this school, and I agree to abide by it.

10) I agree that any previous agreements, whether written or oral, are fully merged into this agreement, and that no other agreement, statement, or promise other than those contained in this contract shall be valid or binding on either party.

11) I agree that if there are deficiencies in my job or personal performance, the Administration of Faith Community Academy ("Administration"), at its sole discretion, may extend to me a Professional Development Plan (PDP) to help facilitate needed changes in my performance. I agree that the Administration, in its sole discretion, may determine that certain acts, deficiencies, or situations are so grave that they may result in immediate dismissal and thus bypass this general procedure. I further agree that the Administration of Faith Community Academy may modify or revoke the plan at its sole discretion, and that failure to complete such a plan before the end of school year does not obligate the school in any way to extend another contract for the next year.

12) I understand and agree that my employment may be terminated before the end of the school year for cause, and that there is no right to continued employment with Faith Community Academy. Where cause exists, the Administration may terminate this agreement, provided that I have been informed of the cause or causes for discharge and have been given an opportunity to respond to it/them prior to final termination. I agree that failure to request a meeting with the Board within seven days of delivery of the termination notice shall waive my right to such a meeting and the termination is final. I agree that the Administration has the sole right to make the dismissal immediate or with longer notice depending upon the reason(s) for dismissal. Cause, as used herein includes, but is not limited to, any conduct tending to reflect discredit upon the school or upon me by impairing my continued usefulness as a Christian role model for the students.

13) I agree that if any provision of this agreement is declared invalid, illegal, or unenforceable, its invalidity, or unenforceability, shall not affect any other provision of this agreement.
