If you registered in 2015, you will only need to provide evidence of Proof of Residency (see below).

Carefully Read Eligibility and Registration/Document Requirements

Eligibility

- The family must reside in Warren Township or children attend School Districts 50 or 56.
- The program is only open to newborn — 10 years of age .
- Although we don't require evidence of income, this program is intended for families that are financially challenged and require assistance.

Registration Procedure and Required Documents

The requirements are based on policies established by the Toys for Tots Foundation.

- All registration must occur on site at **Warren Township Youth Services, 100 S. Greenleaf St., Monday-Friday from 9 am—5 pm.**
- Adult/Guardian must have photo identification.
- Proof of Residence: Illinois driver license, or Illinois state issued ID, or a piece of mail showing your current address in Warren Township. For example: a utility bill (electric, water, cable or gas), vehicle registration card, pension or retirement statement, tuition or invoice/official mail from college or university, Deed/title mortgage rental/lease agreement. Bills should be no more than 2 months old.
- Parent/Guardian is required to show a birth certificate or adoption record for each child birth through 10 years of age (required at the time of registration). This is to ensure we are helping the maximum amount of kids within Warren Township and keeping the integrity of our toy donations.
- Registered families will receive notification of the pick-up date by postcard. Postcards will be sent to the home address as provided. Tentative pick-up date is December 17th, from 8 am—1 pm.

Toys for Tots is an annual event run by the U.S. Marine Corps Reserve. The object of Toys for Tots is to help less fortunate children throughout the United States experience the joy of Christmas. The generous donations provided by community members, help this organization accomplish their goals. The mission is to collect new, unwrapped toys during October, November and December each year, and distribute those toys as Christmas gifts to less fortunate children in the community in which the campaign is conducted.
