holding raffles, a little word to the wise:

Please retain your tickets for two or three months past your drawing date. Keeping the tickets for this reasonable time should

help fend off any stupid attacks. This suggestion was given to me from the Department Judge Advocate. It is in case someone who purchases a ticket and after the draw date wants to attest the drawing by stating, "My ticket was not even in the container to be drawn." Having the tickets on hand can keep from having a big court battle even knowing that their complaint is after the drawing date.

At all of our Conferences and Conventions there is always a registration fee and an "at the door" entrance fee with a possible 50/50 fee. The registration fee normally is for the hosting Detachment to help pay for the costs they incur. The main meeting entrance fee is for the State or National entity having the Conference or Convention. The 50/50 at the main meeting entrance is an **optional** 50/50 drawing. Whoever wins the pot receives 50% of whatever money is collected. The other 50% goes to the entity having the Conference or Convention.

When entering for the business meeting it is required to:

1) Have your Marine Corps League Membership Card. It is required for the Sergeant-At-Arms to insure all who enter (as per the Bylaws) for the main meeting are eligible to be admitted.

2) Be in minimum uniform which is your Marine Corps League Cover. All exceptions are directed to the ruling authority of the Conference/Convention.

The Sergeant-At-Arms does not make the rules; he/she only enforces them.

Senate Confirms David Shulkin as New VA Secretary

confirmed Dr. David Shulkin as the new Veterans Affairs Secretary on February 13th, making him the first non-veteran ever to serve in the post. Shulkin, who currently serves as the head of VA health programs, was approved by a vote of 100-0. He is expected

to be sworn into the Cabinet post on February 14th.

The 57-year-old physician was praised by lawmakers from both parties and veterans advocates as a leader with inside knowledge of the veterans bureaucracy and critical perspective of ways to reform those offerings from his time as a healthcare executive.

"The solutions to VA's problems should be based on common sense rather than partisanship or an extreme agenda, and I think Dr. Shulkin recognizes that," said Senator Jon Tester, D-MT, and ranking member of the Senate Veterans' Affairs Committee.

"He is committed to our nation's veterans



above all. Through the conversations I've had with him over the last year and a half, I think he understands the challenges that are ahead of us in the VA... Dr. Shulkin is on top of it."

Committee Chairman Senator Johnny Isakson, R-GA, called Shulkin

"the right man for the veterans administration" and hailed the vote as a rare moment of bipartisanship in the increasingly divided chamber.

Shulkin is the only member of President Donald Trump's Cabinet to be held over from former President Barack Obama's administration. He's also the first non-veteran to

oversee the department or any of its predecessor agencies. Over the last 94 years, each of the 26 other men to serve in the job boasted military experience.

Shulkin's parents both served in the Army, and he was born on a military base in Illinois. In his confirmation hearing earlier this month, Shulkin said the military and veterans care has played a persistent role in his life.

"As a young doctor, I trained in several VA hospitals," he said. "I view my service at VA as a duty to give back to the men and women who secured the uniquely American freedoms and opportunities we all enjoy, because of sacrifices they made."



He also repeatedly promised not to "privatize" VA services, and told lawmakers he would not have accepted Trump's nomination if it came with such a requirement.

"What I told him is that I am a strong advocate for the VA, that the services that are available in VA are not available in the private sector," Shulkin told senators. "My view of where VA needs to go is an integrated system of care, taking the best of VA and the best in the community, and that's what I would work towards."

In a statement, Veterans of Foreign Wars National Commander Brian Duffy praised the Senate vote as an important step ahead for the community.

"Veterans are very fortunate to have Dr. Shulkin voluntarily stay in what has evolved into the most scrutinized and criticized position in the

"What he brings to the job is a love for veterans, for doing what's right, and for knowing what needs to be done to fix what's broken, to hold employees accountable, and to restore the faith of veterans in their VA. The VFW looks forward to working with him and his staff."

Paul Rieckhoff, CEO of Iraq and Afghanistan Veterans of America, in a statement said his membership supported Shulkin's confirmation "but now the hard work for Shulkin and the President begins."

"Big promises from the campaign must be followed by big outcomes," he said. "Dr. Shulkin knows the VA and should not require time to learn. We expect and deserve to see results right away."

Trump made VA reform a pillar of his presidential campaign, including releasing a 10-point plan which called for more mental health care professionals in the department, a private White House hotline devoted to fielding complaints from veterans, and a commission to "investigate all the fraud, cover-ups, and wrongdoing that has taken place in the VA" in recent years.

Much of that work has been stalled waiting for a new permanent head for the department. Decisions on who will serve as Shulkin's chief of staff, top health official and other key deputies are expected to be announced in coming days.

Shulkin is the ninth permanent secretary confirmed by the Senate since the Department of Veterans Affairs was reorganized in 1989. Each of the other eight were also approved without opposition, either through unanimous or voice votes.

Exclusive: New VA Chief on Public Scrutiny: Bring It

WASHINGTON — The Department of Veterans Affairs has a new message on public scrutiny: Bring it on.

President Trump's pick to lead the agency, VA Secretary David Shulkin, is unveiling a new web site that reveals for the first time exactly how care at VA hospitals compares with nearby private-sector hospitals and national averages. The site has data for roughly 20 hospitals but more will be added soon, the VA says.

The site that went live Wednesday, *access-to-care.va.gov*, also shows if veterans are satisfied with wait times at every hospital and clinic across the country and how long they are actually waiting on average.

Shulkin, the only holdover from the Obama administration in Trump's Cabinet, told *USA TODAY* that he believes transparency is a critical step toward fixing the beleaguered VA, something he said he conveyed to Trump.

"He doesn't understand why people are waiting this long, and he wants to fix it. My answer to him is, the way that you fix this is not by internally motivating people to fix it — you actually need the external environment, people looking, saying I don't understand why it's 45 days," he said.

"In my experience in health care — but it's like every other industry — industries don't change from within, they change from outside competition, and they change from outside forces, and that's very much my philosophy."

That's a marked shift from his predecessor, former Procter & Gamble CEO Bob McDonald, who as secretary focused heavily on trying to spur internal cultural change, assailed critical media coverage and said that revealing internal quality ratings of VA hospitals would cause veterans "unwarranted distress" and possibly dissuade them from getting care.

Shulkin himself had worried veterans might be scared away, but he says now that he's in charge — he was previously undersecretary for health — he decided transparency is the best option. He provided a demonstration of the new web site to *USA TODAY* on Monday that showed wide variations in wait times.

In the greater Los Angeles area, for example, the average wait for new patients seeking mental health appointments ranged from eight days in Long Beach, CA, to 87 days at a clinic in Santa Fe

Springs, CA.

In New York and New Jersey, average waits range from three days at a clinic on Staten Island to 58 days at a VA clinic in Morristown, NJ.

Shulkin said the information will empower the public to ask questions — including members of Congress and others outside the VA who can hold it accountable. And it helps veterans and their family members make more informed decisions about where to seek care.

"It starts giving people now some choice on essentially what they want to do," Shulkin said.

At the Phoenix VA, which made headlines in 2014 after schedulers kept secret wait lists and veterans died waiting to be seen, the average wait is now 18 days for new primary care appointments and eight days for new mental health patients, according to the new site.

But on satisfaction, only 69% of veterans surveyed say they usually got an appointment when they needed one in Phoenix. The national average on that question is 85%, Shulkin said.

He noted that all of the roughly 150 VA hospitals now provide same-day services for veterans needing urgent or immediate appointments, a goal he had set when he started at the agency in 2015.

The site also shows how 19 VA hospitals compare to nearby private-sector facilities on more than a dozen quality measures, including complication rates after hip or knee surgery. It also displays national averages, allowing the public to see where VA care is lagging or better in average quality.

Shulkin is a practicing physician who still sees VA patients via video link in his top-floor office at VA headquarters in Washington. He is quickly ramping up plans to deliver on Trump's campaign promises, including setting up a White House hotline for VA complaints that Shulkin says should be up and running by **June 1**. He is also putting together a task force to investigate fraud and abuse

at the agency.

His philosophy about transparency stems to his early career days in the 1990s, he said, when he was chief medical officer of the University of Pennsylvania Health System. The state of Pennsylvania released death rates for cardiac surgery programs and Penn's was the highest.

"And everyone until then had thought, well Penn was the best. Now all of a sudden we have data, it's the worst," Shulkin said. "Well, I learned — not easily — that was a gift to me to drive internal change, and I could never have stood up as a young kid and said, 'Guys we have a problem here.' But when the reporters and the newspaper



articles were saying you have an outcomes problem here, mortality's three times as high as other hospitals in Pennsylvania, that allowed me to drive internal change."

Shulkin hopes releasing the internal data on the sprawling VA system, which encompasses more than 1,200 medical clinics in addition to hospitals, will help him do the same.

"I really think that this is going to be, when we look back, a turning point for VA because the leaders who aren't focused on what they're doing have no place now to hide and so they're going to have to truly be accountable for their results," he said.

WE EXPERIENCED A larger-than-usual Mid-Winter Conference in Fredericksburg, VA, this past month, followed by a somewhat mediocre turnout from all but East Texas at the Southern Division Conference in Tyler. Next up is the State Convention in Beaumont this June and the National at Overland Park, KS, in August. I encourage all District 2 Detachments to register your Delegates and to have at least one Delegate attend both the State and National Conventions. Your votes do matter, but you don't get them if you do not have at least one Delegate at the Conventions to cast your entitled votes.

You must have a Delegate registered for each block of ten (10) regular and dues-current members as of June 30, but only one of those delegates needs to be at the Conventions to cast all your votes. For example, if you have 41 members on your roster at the end of June that are current on their dues, you must register five (5) delegates in order to cast all 41 votes. If you have just three registered delegates, you will only be allowed thirty (30) votes, provided you have at least one registered delegate at the Convention.



In the news, Texoma Detachment #929 received the National Vice Commandant's Award for maintaining their average unpaid membership at or below 15%. Good job Marines.

With Memorial Day just around the corner, I'd like to share a few tidbits from history...

April 2, 1917 – President Woodrow Wilson asking Congress to declare war against Germany:

"It is a fearful thing to lead this great peaceful people into war, into the most terrible and disastrous of all wars, civilization itself seeming to be in the balance. But the right is more precious than peace, and we shall fight for the things which we have always carried nearest our hearts – for democracy, for the right of those who submit to authority to have a voice in their own governments, for the rights and liberties of small nations, for a universal dominion of right by such a concert of free peoples as shall bring peace and safety to all nations and make the world itself at last free. To such a task we can dedicate our lives and our fortunes, everything that we are and everything that we have, with the pride of those who know that the day has come when America is privileged to spend her blood and her might for the principles that gave her birth and happiness and the peace which she has treasured. God helping her, she can do no other."



July 4, 1917 – General John J. Pershing, commander of the newly arrived American Expeditionary Forces in Europe, made a special pilgrimage to a small cemetery on the outskirts of Paris. There, he and his staff stopped beside a simple grave.

"It is with loving pride we drape the colors in tribute of respect to this citizen of your great republic. And here and now in the presence of the illustrious dead we pledge our hearts and our honor in carrying this war to a successful issue. Lafayette, we are here!"

June 6, 1918 – Nearly 1,100 Marines were killed or wounded on the first day of the Battle of Belleau Wood. The Corps' tenacity led the French to rename the wood Bois de la Brigade de Marine, or "Wood of the Marine Brigade."

I urge each of you to join with your fellow Veteran Service Organizations in remembrance of all those who gave the ultimate sacrifice from the time of our very beginning through the present.








MARINES GETTING READY FOR TRANSITION

I am meeting soon with attorneys from Headquarters Marine Corps to discuss if we can keep the EGA on our uniforms as well as on shirts and other types of garments. Creating a name for a fund and stating that it is a Marine Corps League Fund is both wrong and possibly damaging to us. If you are running a raffle or fundraiser, use your Detachment name and do not use verbiage that might indicate the raffle or fundraiser is approved by or is benefiting the National MCL Headquarters.

Recently I’ve had several complaints about rogue Toys for Tots programs being conducted using the name “Toys for Tots,” using the Toys for Tots logo, wearing Toys for Tots shirts, hats, etc. and then collecting both toys and money and not turning it over to Toys for Tots. This is a serious problem and can result in serious punishment. In order to run any Toys for Tots program you must have the official approval of the Marine Corps National Toys for Tots. Please do not set up unauthorized programs that use the Toys for Tots name but do not follow the Toys for Tots program requirements. Collecting either toys or money under false pretense is a crime, and it must be stopped. If you are issued a cease and desist letter from National Toys for Tots, there will be no second warning if you fail to do just that, cease and desist.



I would like to close by thanking all of the members who go the extra mile and support your Detachments, Departments, and Divisions. You do great work for our fellow Marines, FMF Corpsmen and Navy Chaplains, and you spend countless hours doing so. Please keep up the great work!

Remember our deployed Marines, especially those in harm's way. Keep them in your thoughts and prayers and may they soon be reunited with their families and loved ones.

Afghan Official: Massive U.S. Bomb Death Toll Rises to 94

KABUL, Afghanistan - The number of militants killed in an attack by the largest non-nuclear weapon ever used in combat by the U.S. military has risen to 94, an Afghan official said Saturday.





Ataullah Khogyani, spokesman for the provincial governor in Nangarhar, said the number of Islamic State group dead was up from the 36 reported a day earlier. A Ministry of Defense official had said Friday the number of dead could rise as officials assessed the bomb site in Achin district.

"Fortunately there is no report of civilians being killed in the attack," Khogyani said.

The increased death toll in Nangarhar was

announced as officials in southern Helmand province reported at least 11 civilians were killed and one wounded in two roadside bomb blasts overnight.



The U.S. attack on a tunnel complex in remote eastern Nangarhar province near the Pakistan border killed at least four IS group leaders, Khogyani said. He said a clearance operation to assess the site of the attack was continuing.

The strike using the Massive Ordnance Air Blast bomb, or MOAB, was carried out Thursday against an Islamic State group tunnel complex carved into the mountains that Afghan forces had tried to assault repeatedly in recent weeks in fierce fighting in Nangarhar province.

Former Afghan president Hamid Karzai on Saturday criticized both the Afghan and U.S. governments for the attack in Nangarhar. Addressing a gathering in capital Kabul, Karzai said that allowing the U.S. to carry out the bombing was "treason" and an insult to Afghanistan.

Current President Ashraf Ghani's office said Friday there was "close coordination" between the U.S. military and the Afghan government on the operation, and they were careful to prevent any civilian casualties.

The U.S. estimates 600-800 IS fighters are in Afghanistan, mostly in Nangarhar. The U.S. has concentrated on fighting them while also supporting Afghan forces against the Taliban. The U.S. has more than 8,000 U.S. troops in Afghanistan, training local forces and conducting counterterrorism operations.

In Helmand province, at least 11 civilians were killed and one wounded in two roadside bomb blasts late Friday evening, said Omar Zwak, spokesman for the provincial governor.

“All victims of the attack were innocent civilians including women and children,” said Zwak. The 11 died in a blast in Nawa district when their vehicle was hit by a roadside bomb. Another person was wounded when a second bomb exploded in Lashkar Gah, the capital of Helmand, he said.

Also on Saturday, Khogyani said a district leader and three others were wounded when their vehicle was targeted by a bomb. One of the wounded was Ghalib Mujahid, Bati Kot district chief, he said.

“The district chief and others are out of danger and are not in life-threatening condition,” he said.

Last November, Mujahid was attacked by a sticky bomb attached to the vehicle; he was wounded and his driver was killed.



Marine Corps History

GENERAL ORDERS FOR SENTRIES

(Excerpt from *Warrior Culture of the U.S. Marines*, copyright 2001 Marion F. Sturkey)

The eleven General Orders for sentries never change. They constitute the unyielding bedrock upon which Marines enforce military security in the United States and throughout the world. General Orders dictate the conduct of all Marines on guard duty. These orders apply to all Marines at all bases and outposts in time of peace and in time of war.

Marine recruits in boot camp must memorize these General Orders. Woe be unto the unfortunate recruit who cannot shout out, verbatim and without hesitation, all eleven of them.

Such a recruit will incur a firestorm of wrath from his Drill Instructor. There is sound logic for this rigid training.



The eleven General Orders will guide each Marine throughout his years in the Corps:

1. To take charge of this post and all government property in view.
2. To walk my post in a military manner, keeping always on alert and observing everything that takes place within sight or hearing.
3. To report all violations of orders I am instructed to enforce.
4. To repeat all calls from posts more distant from the guardhouse than my own.
5. To quit my post only when properly relieved.
6. To receive, obey, and pass on to the sentry who relieves me, all orders from the commanding officer, officer of the day, and officers and noncommissioned officers of the guard only.
7. To talk to no one except in line of duty.
8. To give the alarm in case of fire or disorder.
9. To call the corporal of the guard in any case not covered by instructions.
10. To salute all officers and all colors and standards not cased.
11. To be especially watchful at night and, during the time for challenging, to challenge all persons on or near my post and to allow no one to pass without proper authority.

VA Now Providing Online Daily Burial Schedules for Its National Cemeteries

WASHINGTON – The Department of Veterans Affairs (VA) announced today a new online Daily Burial Schedule (DBS) for all VA national cemeteries, which will allow families and loved ones to retrieve

time and location information for those being interred, via its National Cemetery Administration (NCA) website.

“We pride ourselves on continuously improving customer satisfaction and meeting the wishes of Veterans and their loved ones,” said interim Under Secretary for Memorial Affairs Ronald E. Walters.

“We want manageable information for anyone wishing to pay their respects.” The new feature is available to anyone with a smartphone, tablet or computer. Families may also opt out of using this service. Schedules of interments are posted online and updated hourly at: www.cem.va.gov/dailyburialschedule.

The public can search by national cemetery or last name. DBS will give the scheduled committal service date and time, location of the cemetery and funeral home providing services. The location of the committal shelter will be provided at the cemetery. In addition, users may also navigate to the specific VA national cemetery website for directions and further information.

VA operates 135 national cemeteries and 33 soldiers’ lots and monument sites in 40 states and Puerto Rico. More than 4 million Americans, including Veterans of every war and conflict, are buried in VA’s national cemeteries. VA also provides funding to establish, expand, improve and maintain 105 Veterans’ cemeteries in 47 states and territories including tribal trust lands, Guam, and Saipan. For Veterans not buried in a VA national cemetery, VA provides headstones, markers or medallions to commemorate their service.

It appears that some Marines in the DOT left their honor somewhere alongside the road after they took off that Marine Corps uniform.

So, before you believe everything you are told, do your own research and find out what the real truth is, taking into consideration that the DOT Marine Corps League is not a political party, but (for the most part) a group of men and women who want to do the honorable thing.
